B. **ELIGIBILITY REQUIREMENTS**

1. Citizen of the United States.
2. Honorably discharged or separated from the Armed Forces of the United States.
3. Active duty in the Armed Forces of the United States during any of the following periods:

World War II	December 7, 1941-December 31, 1946
Korean Conflict	June 27, 1950-January 31, 1955
Vietnam Conflict	February 28, 1961-May 7, 1975
Desert Storm and Persian Gulf Conflict	August 2, 1990-the date upon which hostilities end.

Commissioned Corps of the US Public Health Services:	July 29, 1945-September 2, 1945
	June 26, 1950-July 3, 1952

OR

The Armed Forces expeditionary medal, navy expeditionary medal, or marine corps expeditionary medal for:

Hostilities in Lebanon	June 1, 1983-December 1, 1987
Hostilities in Grenada	October 23, 1983-November 21, 1983
Hostilities in Panama	December 20, 1989-January 31, 1990

4. Resident of New York State at the time of entry in the Armed Forces of the United States.
5. Resident of New York State at the time of applying for Veterans Credits.
6. If since January 1, 1951, you used your veterans credits for permanent appointment or promotion in New York State or its civil division, you may not claim them again.
