# RESOLUTION NO. \_ - 2024

# RESOLUTION AUTHORIZING AGREEMENTS BETWEEN DEPARTMENT OF SOCIAL SERVICES AND NEW YORK STATE OFFICE OF CHILDREN AND FAMILY SERVICES AND WITH COMMUNITY ACTION PLANNING COUNCIL OF JEFFERSON COUNTY, INC.

Introduced by Legislator Jessica Moser, Chair of the Human Services Committee.

WHEREAS, the Commissioner of Social Services of Lewis County is an authorized Social Services official responsible and designated by the New York State Office of Children and Family Services, insofar as funds are available for that purpose, to register and inspect family daycare and school-aged child care providers in Lewis County; and

WHEREAS, the Community Action Planning Council of Jefferson County, Inc. ("CAPC") is qualified by its present established base in the community and is disposed to fulfill the required responsibilities of the Local Commissioner in fulfilling the obligation to inspect and register daycare providers. The Commissioner of Lewis County Department of Social Services ("DSS") desires to enter into an Agreement with CAPC to provide such services; and

WHEREAS, the Board of Legislators wishes to authorize said agreements;

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. That the Lewis County Board of Legislators hereby authorizes Agreements between the County of Lewis, by and through the Department of Social Services with:

A. New York State Office of Children and Family Services for the purpose of providing federal funding to the Lewis County Department of Social Services in the amount of \$10,567.50 quarterly (Maximum Funding Amount of \$42,270.00), for an acceptable level of compliance and performance as specified by the Division of Childcare Services for registration and inspection of child care providers.

and

B. Community Action Planning Council of Jefferson County, Inc. for the purpose of conducting registration and inspection of family day care and school aged child care providers in Lewis County, at an annual cost not to exceed \$40,157.00, payable in quarterly installments of \$10,039.25 upon receipt of a completed Quarterly Registration Review Report from the DCCS Regional Office.

Section 2. That the term of these Agreements shall be from January 1, 2024 through December 31, 2024. The cost of these services are 100% federally funded.

Section 3. That the Lewis County Commissioner of Social Services is hereby authorized to make, execute, seal and deliver the New York State Office of Children and Family Services agreement and any extensions thereto, pending review and approval by the County Attorney.

Section 4. That the Chair or Vice-Chair of the Board of Legislators is hereby authorized to make, execute, seal and deliver the Community Action Planning Council of Jefferson County, Inc. Agreement, and any extensions thereto provided the amount remains the same, pending approval by the County Attorney.

Section 5. That the within Resolution shall take effect immediately.

- The new Deputy Director joined the department on 1/1/24.
- The Office of Addiction Services And Support(OASAS) substance use prevention services transition and planning has been paused. This is a result of a delay in "finalizing" closure and building logistics.

- The Office of Menal Health Act Team service is still on hold as the organization attempts to fill open positions required to operate the program.

PROJECT	UPDATE
Vet Peer-to-peer	The program staff continue to do local outreach in the community. They have secured housing for 2 local veterans. The program has received donations of clothing for the Tug Hill quilters.
Opioid settlement money	It was decided to focus on social determinants of health for utilization of the funding dollars. A portion of the funding will be provided to the future Lewis County prevention services provider
OASAS Opioid abatement money	State aid for 2024 has been awarded.
24/7 mobile crisis	The Community Services Department, Office of Mental Health and Jefferson County are in preliminary discussion to determine if it would be beneficial to coordinate a bi county on the 24/7 crisis service.
OD mapping	The group, which is comprised of law enforcement from Lewis and Oneida County, drug task force, EMS, probation, parole, community-based organizations, public health and community services, meets monthly. The purpose is to share information, gather data and try and engage people who have had an overdose or families to services.

Re: Lewis County Probation Monthly Summary

1. We are currently supervising 173 adult probationers, 42 of whom are DWI cases. In addition, we supervise 18 conditional discharge ignition interlock cases, 5 Drug Court cases, 7 JD cases, 2 pre-trial release case, and are working on 16 pre-sentence investigations.

- 2. Lewis County Probation had an outstanding Violation of Probation warrant issued by the Hon. Daniel R. King back in August of 2023. In cooperation with the Sheriff's Office, we learned that the offender was likely in South Carolina. After consulting with the District Attorney's Office, it was decided that Lewis County would extradite this offender if located. The Myrtle Beach Police Department located the offender on an unrelated matter on 12/12/2023. The DA's office and the Sheriff's Department developed a plan to pick up the offender. The offender has since been returned to Lewis County on our Violation of Probation warrant. The offender is currently in custody at the Lewis County Jail. While extradition proceedings are rare in Lewis County, they do take place. In the case of interstate probation transfers, extraditions are mandatory in certain situations according to federal law. The probation department currently has two interstate probation transfer cases being supervised in different states. Should either of these individuals violate their probation, Lewis County is required to extradite the offender.
- 3. Now that our firearms policy has been adopted by the full board of legislators, we are continuing to plan for this policy change. We continue discussions with Sheriff Carpinelli and Jefferson County Probation. Both the Sheriff's Office and Jefferson County Probation have offered to provide our department with the initial firearms training. We purchased firearm safes for our office. The building and grounds department attached the firearm safes to walls in our office last week. I would anticipate that in the second half of 2024 our probation officers will begin to be armed while on duty.

## **Other Program Highlights**

The Medicaid Weekly county share payment has increased from \$97,889 to \$104, 906.

Emergency HEAP opened on January 2, 2024. DSS received 49 emergency applications from the 2<sup>nd</sup> to the 5<sup>th</sup>.

DSS had 5 claims totaling \$1,842.53 for skimmed SNAP benefits. One claim

was denied for replacement benefits totaling \$100. The remaining skimmed benefits were in and out of state transactions.

DSS celebrated a foster child adoption in December after of being involved with DSS through preventive and then foster care services for 4 years and 10 months.

January is considered Human Trafficking Awareness Month. The Lewis County Safe Harbour Team that works with youth that have been sexually exploited or at risk of exploitation are currently working with 15 youth.

The Federal Homeless Point In Time Count is scheduled for Thursday January 25<sup>th</sup>. This is a day selected by HUD for every state and municipality to count the numbers of homeless. The data gleaned by the count assists communities in applying for and receiving HUD funds through our local Continuum of Care; Points North Housing Coalition. Lewis County joins Jefferson and St Lawrence counties in planning for the count for the North Country region.
