# RESOLUTION APPOINTING MEMBER TO ALCOHOL & SUBSTANCE ABUSE SUBCOMMITTEE OF COMMUNITY SERVICES BOARD

# RESOLUTION AUTHORIZING AGREEMENT BETWEEN LEWIS COUNTY COMMUNITY SERVICES DEPARTMENT AND FORT DRUM REGIONAL HEALTH PLANNING ORGANIZATION

WHEREAS, the Lewis County Community Services Director desires to enter into an Agreement with Fort Drum Regional Health Planning Organization to act as a project manager for a Mobile Crisis service in Lewis County; and

WHEREAS, the Director of Lewis County Community Services has submitted a plan for Mobile Crisis services to the Office of Mental Health (OMH) to use the State Aid grant of \$300,000 (per year, for 2 years) to create these services in Lewis County; and

WHEREAS, the Board of Legislators wishes to enter into this agreement;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That the Lewis County Board of Legislators hereby authorizes an Agreement with Fort Drum Regional Health Planning Organization to act as a project manager for the development of behavioral health Mobile Crisis services in Lewis County at a cost not to exceed \$150,000.00; payable from Community Services OMH Crisis Management Budget Line.

Section 2. That the term is retroactive to January 15, 2024, through December 31, 2024.

Section 3. That the Chair or Vice-Chair of the Board of Legislators is hereby authorized to make, execute, seal, and deliver such Agreement, pending approval by the County Attorney.

# RESOLUTION AUTHORIZING ACCEPTANCE OF THE 2023-2024 NYS DIVISION OF CRIMINAL JUSTICE AWARD FOR CERTIFIED PRETRIAL SERVICES THROUGH THE PROBATION DEPARTMENT AND APPROPRIATION OF FUNDS

WHEREAS, the NYS Division of Criminal Justice Services (DCJS) recently advised that the County will receive 2023-24 funding to offset the costs associated with provision of certified pretrial services in the amount of \$60,000.00 for the period of April 1, 2023 through March 31, 2024; and

WHEREAS, the pretrial certified services associated with this award include but are not limited to costs for screening, assessments, supervision and reporting; and

WHEREAS, the Board of Legislators wishes to accept such award and appropriate the funds;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That the Lewis County Board of Legislators hereby accepts the NYS DCJS funding award of \$60,000.00 to offset the costs associated with certified pretrial services provided by the Probation Department.

Section 2. That the Lewis County Board of Legislators hereby authorizes the Treasurer to appropriate the funds when received and to deposit same into the appropriate Probation Department budget lines.

Section 3. That the Chairman or Vice-Chairman of the Board of Legislators is hereby authorized to execute, seal and deliver any documents, required by NYS DCJS under the award of said funds, pending review by the County Attorney.

#### **Community Services Office**

- The prevention services transition and planning has been resumed. Temporary access to prevention services is being covered by local SUD providers/coalitions.
- Annual Report will be due end of March.
- The department is working on updating the bylaws, member orientation and structure.

#### **Agency Updates:**

- Staffing/workforce concerns.
- New York State Office for People with Developmental Disabilities (OPWDD) providers are concerned re a
  program access to respite has been discontinued. Rationale is the services are duplicative to other waiver
  services. However, to access these services is a bit more complicated to obtain and some people may not
  meet criteria.
- Credo and Transitional Living Services continue to move forward with plans for merger. The new entity will be Thrive Wellness and Recovery.
- Credo will be seeing clients at DSS once a week.
- Volunteer Transportation Center (VTC) is working with the Lewis County Planning Department looking at "micro transit" opportunities to address transportation barriers.

#### **Tri County**

Currently the tri county area is collaborating on two initiatives:

- Office of Mental Health (OMH) mobile crisis.
- OMH/Department of Health (DOH) improving discharge plans for those seeking mental health services.

Vet Peer-to-Peer	The department is working with MHA staff. Goal to streamline and define program reports, continue to network, and increase program participation within the community.
Opioid settlement money	The SUD/MH Subcommittee will begin meeting monthly to develop a plan to use dollars.  This will involve gathering data, community input and ongoing attendance at statewide meetings.
OASAS Opioid abatement money	See above.
OMH 24/7 mobile crisis	Agreed to partner with Jefferson County and engage Fort Drum Regional Health Planning Organization as project manager.
OD mapping	January meeting was cancelled.
Hospital and Community Connections	OMH continues to coordinate with the tri county providers and community services department. Have identified using a current well-established meeting to host the partners. Next steps to look at OMH/DOH expectation for better discharge planning and how to operationalize expectations within emergency departments, hospitals and community-based support.



Re: Lewis County Probation Monthly Summary

- 1. We are currently supervising 172 adult probationers, 42 of whom are DWI cases. In addition, we supervise 14 conditional discharge ignition interlock cases, 5 Drug Court cases, 12 JD cases, 2 pre-trial release case, and are working on 7 pre-sentence investigations (one of which is for a Court in Jefferson County). I would note that this is the lowest number of pre-sentence investigations that we have been ordered to complete in my tenure as Probation Director. Even during the height of the pandemic, when Court activity was severely limited, we were still being ordered to complete investigations. Pre-sentence investigations are required for all felony convictions. Pre-sentence investigations are also required for misdemeanor convictions whenever there will be a sentence to probation, a sentence of imprisonment for more than 180 days, and consecutive sentences of imprisonment with terms aggregating more than 90 days.
- 2. Lewis County Probation had to utilize non-secure detention from February 1 through February 9, 2024. Lewis County Family Court ordered a juvenile under our supervision to be held in non-secure detention. As the board of legislators is aware, we are fortunate to have a contract with a local family who can provide non-secure detention services within their family home. The residence is approved annually through the NYS Office of Children and Family Services. The utilization of the detention bed locally saves this department a great deal of time in transporting the youth to and from Court appearances. The bed space locally is also significantly cheaper than detention beds throughout the state, saving the county a significant amount of money when detention beds are required.
- 3. On February 29, 2024, Lowville Academy will be hosting their annual career day. Lewis County Probation is excited to be part of this great event once again this year. Students will get the opportunity to learn about careers in probation. Probation Officers will also take part in mock job interviews with students. We also take the opportunity to promote the message of the Lewis County STOP-DWI program with the students. On March 8, 2024, Lewis County STOP-DWI and Lewis County Probation will be at Copenhagen Central School in conjunction with the Save a Life Tour. Students will learn about the dangers of impaired driving. This is another great opportunity for our department to engage with area youth.

will be onsite at the WorkPlace on the 1<sup>st</sup> and 3<sup>rd</sup> Mondays of each month to answer questions regarding Child Care. This is in addition to DSS providing Child Care Subsidy payments for eligible families.

The Lewis County Child Support Enforcement Unit is ranked #1 in the state for Child Support arrears collections.

Lewis County is responsible for 50% of an IGT Medical Assistance payment to LCGH totaling \$6.9 million. These are payments made to public general hospitals operated by counties, at the election of the social services district. The remaining 50% is a federal payment.

DSS is the lead agency for PINS (Persons In Need of Supervision) Services. A recent amendment of the family court act requires these records to now be expunged or sealed and not admissible in any court proceeding without consent of the juvenile or person(s) legally responsible for their care.
