RESOLUTION NO. - 2024

RESOLUTION AUTHORIZING AGREEMENTS BETWEEN LEWIS COUNTY PUBLIC HEALTH AGENCY AND PROFESSIONALS PROVIDING RELATED SERVICES FOR PRE-K SPECIAL EDUCATION CHILDREN

Introduced by Legislator Jessica Moser, Chair of the Human Services Committee.

WHEREAS, pursuant to Section 4410 of the New York State Education Law, Lewis County Public Health ("Public Health") is tasked with providing certain Preschool Services for children with disabilities as defined in the statute; and

WHEREAS, if a child requires particular related services in Pre-School, including but not limited to occupational therapy, physical therapy, speech therapy, psychological counseling, etc., Public Health is required to provide qualified persons to provide such services; and

WHEREAS, Public Health seeks to have the ability to enter into contracts with various qualified professionals who have the licensure and credentialing to provide related services for children in the Pre-School Special Education program, for a term of at least one year, with automatic annual renewals, at the rates set by NYSED and the Lewis County Board of Legislators; and

WHEREAS, the Lewis County Board of Legislators seeks to approve and authorize said agreements, so long as Public Health maintains and provides the Board with a monthly list of the qualified professionals with whom the Agency intends to engage;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section I. That the Lewis County Board of Legislators hereby authorizes the Lewis County Public Health Agency to enter into agreements with qualified professional to provide related therapy services required for children in Pre-School Special Education as required under Section 4410 of the NYS Education Law.

Section 2. That the agreements for said related services shall be for one year periods, with automatic annual renewals unless terminated by either party upon written notice prior to the end of the term, with the hourly compensation rate as set by NYSED and as adopted by the Board of Legislators.

Section 3. That the Lewis County Board of Legislators hereby authorizes the Chair or Vice-Chair of the Board, together with the Director of Lewis County Public Health to execute and deliver such Agreements and any amendments thereto, upon

review and approval of terms by the County Attorney. The PH Director is to provide the Board with a list of all such contracts on a monthly basis.

Section 4. That the within resolution shall take effect immediately.

RESOLUTION NO. __ - 2024

FOR THE SHERIFF'S DEPARTMENT

Introduced by Legislator Jessica Moser, Chair of the Health & Human Services Committee.

WHEREAS, the County of Lewis seeks to enter into a three-year Agreement with PowerDMS, Inc. d/b/a NeoGov, to implement its PowerDMS software program with training, policy and scheduling features for use by the Sheriff's Department; and

WHEREAS, NeoGov has provided a quote and scope of services for this system over three years, at a cost of \$35,639.00 (\$13,511.10 year 1, \$10,538.00 year 2, and \$11,589.90 year 3) from July 1, 2024 through June 30, 2027; and

WHEREAS, the Board of Legislators seeks to authorize this expenditure and enter into this software Agreement;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That the Lewis County Board of Legislators hereby authorizes an Agreement with PowerDMS, Inc., d/b/a NeoGov, to implement its PowerDMS software system for the benefit of the Sheriff's Department at a cost of \$35,639.00 (\$13,511.10 year 1, \$10,538.00 year 2, and \$11,589.90 year 3) for a three-year period, in accordance with its proposal dated June 27, 2024.

Section 2. That the term of the agreement is from July 1, 2024 through June 30, 2027.

Section 3. That the Chair or Vice-Chair of the Board of Legislators is hereby authorized to make, execute, seal and deliver such Agreement, upon such form(s) as may be approved by the County Attorney.

Section 4. That the within resolution shall take effect immediately.

RESOLUTION NO. __ - 2024

RESOLUTION AUTHORIZING LEASE AGREEMENT BETWEEN THE COUNTY OF LEWIS AND CHILDRENS HOME OF JEFFERSON COUNTY FOR USE OF SPACE AT THE HUMAN SERVICES BUILDING TO PROVIDE COUNSELING & THERAPY PROFESSIONAL SERVICES FOR THE BENEFIT OF LEWIS COUNTY RESIDENTS

Introduced by Legislator Jessica Moser, Chair of the Human Services Committee.

WHEREAS, the Director of Community Services and Commissioner of Lewis County Social Services seek to assist in having additional counseling services available to residents in Lewis County; and

WHEREAS, the Childrens Home of Jefferson County (CHJC) is willing to provide qualified counselors to meet with patients/clients in Lewis County two (2) days per week, by leasing Room # 140 in the Human Services Building on Outer Stowe Street. CHJC will furnish the room as needed for these sessions, and will advise the Commissioner of the actual days they intend to use the space so that DSS can have the 120 square foot space set up and equipped for its other functions on the other days; and

WHEREAS, CHJC has agreed to pay the sum of \$750.00 per month as rent for the space and the other amenities provided in and by the Human Services Building, for a one-year period, with an option to renew upon mutual agreement; said agreement to become effective upon full execution of the lease;

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. The Lewis County Board of Legislators hereby authorizes a lease agreement between the County of Lewis and the Children's Home of Jefferson County, Watertown, NY, for use of Room #140 in the Human Services Building on Outer Stowe Street, Lowville, NY for two (2) days per week, together with all the amenities provided at that building, in order to conduct professional counseling and therapy sessions with patients/clients from Lewis County.

Section 2. The terms of the lease shall include monthly rental in the amount of \$750.00 for the use of the 120 square foot space of Room # 140, two days per week, with the other amenities offered by the building, with CHJC providing the furnishings it deems appropriate for such services. CHJC shall provide the Commissioner with the actual dates of use in advance. The lease shall commence immediately upon execution of the lease agreement, and continue for a one-year period, with the option to renew upon mutual agreement.

Section 3. The Chair or the Vice-Chair of the Board of Legislators are hereby authorized to execute and deliver such Lease Agreement, upon such terms and conditions recommended by the County Attorney.

Section 4. That this resolution shall take effect immediately.



Re: Lewis County Probation Monthly Summary

1. We are currently supervising 154 adult probationers, 36 of whom are DWI cases. In addition, we supervise 11 conditional discharge ignition interlock cases, 4 Drug Court cases, 20 JD cases, and are working on 22 pre-sentence investigations.

- 2. We currently have the privilege of having three BOCES Criminal Justice interns in our office from April 16th through May 31st. We have two students from Lowville Academy and one from Copenhagen Central School. All the officers here enjoy having the opportunity to show the students what we do. We have been very fortunate to have excellent interns every year who are genuinely interested in pursuing careers in the criminal justice field.
- 3. Lewis County STOP-DWI is very happy to have been invited to participate in two upcoming mock accidents at area schools. On March 17, Beaver River school will be conducting a mock DWI accident at the school. On March 23, South Lewis will be conducting a mock accident at the school which will incorporate both distracted and impaired driving. Both schools have chosen to hold the mock accidents immediately preceding the prom. This is an excellent opportunity for students to see first-hand the dangers of impaired driving. Numerous first responders from each school community will be volunteering their time and efforts to make these mock accidents a success. STOP-DWI will be on hand to remind the students that impaired driving crashes are completely preventable. We want students and their families to enjoy the prom and graduation season but do so responsibly. STOP-DWI encourages everyone to "have a plan" to get home safely.

Other Program Highlights

DSS transitioned phone systems on April 9 and 16 to Ring Central matching most other County Departments. Phones were ported in batches given the large number of devices in use; approximately 84.

The Lewis County Warming Center closed on the morning of April 8th. 307 bed nights were used from October 1, 2023 to April 8, 2024.

The Lewis County Priorities Council, cochaired by the Commissioner; hosted a Housing Collaborative Meeting on April 30th. Approximately 25 people from multiple agencies attended, homeless numbers were reviewed as well as various rental support programs. We then moved
