

**FIRST DAY
ANNUAL SESSION
November 2, 2021**

The meeting was called to order at 5:10 p.m. by the Chairman of the Board, Lawrence Dolhof.

Roll Call: 9 Legislators were present, Legislators Burns had been excused. There were 16 other persons in attendance.

Legislator Gilbert gave the invocation. Chairman Dolhof lead the Pledge of Allegiance to the Flag and then declared the October 5, 2021 meeting minutes approved by general consent.

REPORT OF THE FINANCE AND RULES COMMITTEE:

The Finance and Rules Committee had met and recommended to waive the rules to allow action on late resolutions.

Legislator Virkler made a motion to waive the rules, seconded by Legislator Kulzer and carried.

PRIVILEGE OF THE FLOOR:

Erik Griffin of Lowville, NY questioned why Resolution No. 262-2021 which was auditing and allowing claims to be paid in the amount of \$1,966,123.92 didn't provide detail on each expense as that is a large amount of money. He cited other organizations, like the American Legion, that provide detail on how they are spending funds. It was explained that Legislators each receive a list of these claims each month and the public can obtain a copy through a FOIL request from the County Attorney's Office.

He voiced his concerns with the Lewis County General Hospital billing process stating that several people have been receiving invoices from inside the state and from outside of the state. He went on to question how the hospital went from being in the red ink to now being in the black ink. The Chairman reminded Mr. Griffin that privilege of the floor is to make a statement to the Board of Legislators not a dialogue session. Mr. Griffin exclaimed "You don't deserve to be a politician!" He continued by explaining that he was running to be a voice for the people, who are the ones who decide which way government should go.

He called on the legislators to start telling the truth about what is going on and stop playing games. Chairman Dolhof stated that he wasn't aware of any legislator who was playing games. Mr. Griffin explained that by not answering his question about how the hospital got out

of the red and into the black was playing games. He concluded by stating that his source, who is in insurance, told him that the county no longer owns the hospital.

PRESENTATION OF COMMUNICATIONS AND NOTICES:

A resolution from Livingston County was received Supporting Operation Green Light for Active Military Service Members in Transition to Civilian Life.

REPORTS OF COUNTY OFFICERS AND DEPARTMENTS:

Legislators received the Highway & Solid Waste October Audit reports. Senior Codes Officer, Ward Dailey submitted a report on an unsafe structure located at 6551 Number Four Road in the Town of Watson.

The 2022 Tentative County Budget has been filed with the Clerk of the Board by Budget Officer Ryan Piche. The semi-annual report of mortgage tax receipts and disbursements was received from the County Clerk and County Treasurer for the period of April 1, 2021 through September 30, 2021. Chairman Dolhof reported last week he learned that County Manager, Ryan Piche, recently received the Credentialed Manager designation from the International County Management Association. The prestigious credential designation is awarded to members who demonstrate significant experience as a senior management executive in local government, with a commitment to high integrity and professional development. Ryan is one of only six active credentialed managers in New York State. Chairman Dolhof congratulated Ryan on behalf of the whole board on this distinguished achievement and recognition so early in his career and personally thank him for the exceptional leadership, management, innovation and enthusiasm he brings to Lewis County as the County Manager.

RESOLUTION NO. 264 - 2021
RESOLUTION AUTHORIZING INTERMUNICIPAL AGREEMENT BETWEEN
THE COUNTY OF LEWIS AND THE TOWN OF GREIG FOR FLOOD DAMAGE
PREVENTION ADMINISTRATION AND ENFORCEMENT

Introduced by Legislator Jerry King, Chair of the General Services Committee.

WHEREAS, the Federal Emergency Management Agency (FEMA) and the NYS Department of Environmental Conservation (NYSDEC) have promulgated regulations concerning the National Flood Insurance Program (NFIP), which, inter alia, require Towns/Villages to enact a local law adopting certain floodplain management regulations; and

WHEREAS, the local law must include the designation of a “Local Administrator” as defined in such local law to administer and implement the regulations, including enforcement thereof; and

WHEREAS, the Town of Greig has enacted a local law or ordinance related to Flood Damage Prevention Administration and Enforcement and designated the Lewis County Code Enforcement Office as the Local Administrator to administer and implement its floodplain management regulations, by granting or denying Flood Plain Development permits and enforcement in accordance with their provisions and regulations; and

WHEREAS, pursuant to Article 5-G of the General Municipal Law and Town Law § 284 [4](d), the County and Town/Village are authorized to enter into intermunicipal agreements to carry out all or a portion of the ministerial functions related to land use regulation within such Town/Village and to provide for land use administration and enforcement programs and activities provided for herein; and

WHEREAS, the County of Lewis wishes to promote inter-governmental cooperation to the extent of offering to have the Lewis County Codes Department perform certain ministerial functions for the purpose of administering and enforcing the zoning and land use regulations that pertain to Floodplain Damage and Prevention, including to act as the Local Administrator on behalf of the Town, in accordance with Federal and State floodplain prevention regulations and the Town of Greig Floodplain Management Program under its local law;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That the Lewis County Board of Legislators hereby authorizes an Intermunicipal Agreement between the County of Lewis and the Town of Greig for the Lewis County Codes Department to be designated as the Town’s “Local Administrator” under its local law, to administer and implement the regulations of the Town of Greig’s Flood Plan Management Program, including enforcement, together with the Federal and State Floodplain Management Regulations.

Section 2. That the Chairman or Vice-Chairman of the Board of Legislators is hereby authorized to make, execute, seal and deliver such Agreement, pending approval by the County Attorney.

Section 3. That the within resolution shall take effect immediately.

WHEREAS, the Community Services Board is a local governmental unit established by the Lewis County Board of Legislators pursuant to the authority granted in Mental Hygiene Law § 41.05; and

WHEREAS, the Community Services Board is responsible to provide local or unified mental health services and facilities directly and/or by contract for the provision of those services by other units of local or state government, by voluntary agencies or by professionally qualified individuals; and

WHEREAS, the Community Services Board has reviewed the proposals for the following providers of mental health services and has determined that these services are necessary to meet the needs of the community at a reasonable cost; and

WHEREAS, the Community Services Board receives state aid funding for some of these services by providers, and may receive adjustments to the initial state aid funding for each named provider agency based upon a Cost Of Living Adjustment (“COLA”) or other funding adjustment determined by the state; and

WHEREAS, the Community Services Board has met to consider the proposed agreements with the following service providers and has resolved to recommend to the Board of Legislators to enter into three (3) year contracts, subject to annual modification in the amounts payable to the providers, including any COLA funding adjustment granted by the state for each year’s funding;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That the Lewis County Board of Legislators hereby authorizes three-year Agreements between the County of Lewis and the following various providers for program services, with the following amounts set forth for as the 2022 funding, plus any financial adjustment(s) made by the State to said annual amount for COLA:

RESOLUTION NO. 270 - 2021
RESOLUTION AUTHORIZING AGREEMENT BETWEEN COUNTY OF LEWIS AND TOWNS OF HARRISBURG AND PINCKNEY FOR TRANSFER OF RIVER ROAD BRIDGE (BIN # 3340140) AND PROVISION OF \$179,000.00 TOWARD COSTS FOR BRIDGE REMOVAL AND REPLACEMENT WITH CULVERT

Introduced by Legislator Jerry King, Chair of the General Services Committee.

WHEREAS, the Lewis County Superintendent of Highways is charged with responsibility for maintenance of bridges within the municipalities comprising Lewis County; and

WHEREAS, the Superintendent of Highways closed the River Road Bridge (identified as Bridge Bin #3340140) which will be in need of significant repairs and ultimate replacement; and

WHEREAS, the Towns of Harrisburg and Pinckney seek to have the County transfer its title and ownership interest in the bridge property, with the intention of the Towns removing the bridge and replacing it with a culvert and other required materials through the financial assistance from the County in the amount of \$179,000.00 toward the costs of materials for this conversion, subject to receipt of appropriate permit(s) and approvals required by the NYS Department of Environmental Conservation (NYS DEC); and

WHEREAS, the cost to the County in repairing/replacing and maintaining this bridge in the short term and long term will be greater than the financial assistance sought by the Towns in its proposal, and will forever eliminate the County's responsibilities for maintenance of the bridge; and

WHEREAS, the Superintendent of Highways requests that the Board authorize this transfer of ownership to the Towns of Harrisburg and Pinckney to share in the responsibility of removing the bridge and converting for installation of a culvert, subject to the Towns' receipt of proper permit(s) and approvals as may be required by the NYS DEC for conversion from bridge to culvert, and to transfer the amount of \$179,000.00 from the County to the Town of Harrisburg toward the material costs of this undertaking.

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That the Lewis County Board of Legislators hereby approves and authorizes a joint agreement with the Towns of Harrisburg and Pinckney for the transfer of title and ownership of the River Road Bridge, (Bridge Bin #3340140) to the named Towns, together with the sum of \$179,000.00 to the Town of Harrisburg toward the material costs associated with removal of the bridge and replacement of same with appropriate culverts and other required materials, provided that the Towns comply with and receive all necessary permits and approvals from the NYS DEC.

Section 1. That the Lewis County Board of Legislators hereby approves the renewal web-based hosting agreement with the Development Authority of the North Country ("DANC") to formally outline the continued scope of GIS hosting and maintenance services with access to DANC's IMA.

RESOLUTION AUTHORIZING EXEMPTION FROM TAXATION FOR CERTAIN REAL PROPERTY OWNED BY THE TOWNS AND VILLAGES IN LEWIS COUNTY AND USED FOR PRODUCTION AND TRANSMISSION OF PUBLIC WATER AND SEWER SYSTEMS BENEFITTING LEWIS COUNTY RESIDENTS AND BUSINESSES

Introduced by Legislator Thomas Osborne, Chair of the Finance & Rules Committee.

WHEREAS, Real Property Tax Law § 406(3) provides that municipal property located outside such municipality's boundaries which is used as a public sewage disposal or water plant or system, may be deemed partially or wholly exempt from taxation by any municipal corporation where the property is located, provided that the governing board thereof shall so agree in writing; and

WHEREAS, the Board of Legislators adopted Resolution No. 74 – 1997 on April 1, 1997, whereby the then Board of Legislators authorized a written agreement declaring Tax Parcel No. 182.00-03-01.12 owned by the Village of Lowville and located in the Town of Watson, to be wholly exempt from County taxation for so long as the property is used for a public purpose satisfying the requirements of Real Property Law § 406. Thereafter, an agreement was entered into with the Village of Lowville to declare this parcel exempt from County taxation pursuant to RPTL § 406; and

WHEREAS, on February 16, 2011, the Board of Legislators adopted Resolution No. 47 – 2011, applicable to the tax roll established as of March 1, 2011, whereby the Board established a uniform tax exemption policy and procedure to authorize a 100% exemption from County real property taxes for a town or village facility used for the production and transmission of public water or for the treatment and disposal of sewage, where such facilities were located outside the town's or village's boundaries, upon the written request of the applicant-town or village; and

WHEREAS, the Taxation Committee of the Board of Legislators thereafter conducted an extensive review of the tax exemptions granted under this policy and determined that it was in the public interest of Lewis County taxpayers that such exemption be phased out entirely over a period of four years (2012-2015), and recommended to the Board of Legislators that the exemption policy be modified accordingly; and

WHEREAS, on August 2, 2011, the Board of Legislators adopted Resolution No. 268 – 2011 whereby the Board authorized a reduction in the foregoing tax exemption by 25% per year commencing with the tax roll established as of March 1, 2012 and ending with tax roll March 1, 2015 and thereafter when no exemption would be granted for municipal facilities used for the production and transmission of public water or for the treatment and disposal of sewage, where such facilities are located outside such municipality's boundaries; and

WHEREAS, on March 6, 2012, a Resolution was introduced to have Tax Parcel 182-03-01.12 owned by the Village of Lowville located in the Town of Watson, be wholly exempt from County taxation and be an exception to the phase out of exemption for municipal facilities as was set forth in Resolution No. 268-2011. Said Resolution was defeated; and

WHEREAS, the current County Board of Legislators seeks to revisit this policy in conjunction with its efforts and support for economic development in Lewis County. The Board recognizes the importance of infrastructure systems such as water, sewer and energy that are capable of upgrades, expansion and efficient maintenance and operation, to attract potential businesses to the County; and

WHEREAS, the County has witnessed from various studies, including the Southern Lewis County Water Study and the recently formed Central Lewis County Water Study, that these basic resources must be able to expand and be properly maintained in order to attract viable businesses to our County; with the County tax on local municipal facilities which benefit county residents and businesses, not to be a disincentive to the County's towns and villages to expand, to properly maintain their systems, and to work cooperatively in support of the County's Economic Development efforts; and

WHEREAS, the Lewis County Board of Legislators seeks to treat its towns and villages equally and fairly with respect to county real property tax exemptions for their respective facilities used for the production and transmission of public water and/or for the treatment and disposal of sewage, where such facilities are located outside the town/village boundaries and remain public systems which serve the residents and businesses in Lewis County, and which can expand to support growth and aid in economic development in the County; and

WHEREAS, by Resolutions over the past few years, the Board of Legislators has approved yearly one-time distribution payments to certain named Villages in the County who have water district infrastructure/systems, to assist with expenses associated with each Village's water infrastructure system costs for maintenance and upgrades so that overall economic development could improve in the County where water infrastructures are currently maintained; and

WHEREAS, the Lewis County Board of Legislators finds that it is in the public interest for the Board to re-examine its position and policy with respect to granting a tax exemption to such towns and villages in Lewis County who own real property outside its boundaries, and for which such property is used for the production and transmission of public water and/or sewer treatment and disposal which directly benefits the residents and businesses in the County of Lewis, to which this exemption would solely apply. The County acknowledges that this policy and decision equates to an annual County tax loss of over \$75,000.00.

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. All prior Resolutions pertaining to the grant or termination of the county real property tax exemption to Lewis County Villages for their facilities owned outside their boundaries and used for the production and transmission of public water and/or sewer treatment and disposal which solely benefit Lewis County residents and businesses, are hereby rescinded.

Section 2. The Board of Legislators hereby establishes the following tax exemption policy with respect to Lewis County towns and villages which own real property located outside

the municipality's boundaries which support its water or sewer facilities, and with such exemption to only apply with respect to County taxes on same:

1. The exemption from County taxation shall apply in whole or in part, at the discretion of the County, to the real property owned by a Lewis County Town or Village and located outside that municipality's boundaries for which an exemption is eligible pursuant to RPTL §406 (3).
2. The municipality seeking the exemption must be a Lewis County town or village, and the property must be classified and used in whole or in part by the municipality for the production, storage and/or transmission of public water or the treatment and/or disposal of public sewage which specifically services the residents and businesses in Lewis County. The municipality must properly and regularly service and maintain its system(s).
3. The exemption shall remain in effect for all future years, so long as there is no change in the use and maintenance of the subject properties as described in sub-paragraph 2 above, and provided that the municipality continues to properly and regularly service, maintain and upgrade its system(s); and further subject to the County's continuing right to review and take further and/or different action on these properties and the exemption at any time.
4. The County of Lewis, acting by and through the Finance and Rules Committee of the Board of Legislators, shall periodically review the exemptions granted pursuant to this uniform tax exemption policy in order to assure that the policy is being applied appropriately by the local assessing unit. The County expressly reserves its right to challenge and, if necessary, to take corrective action with regard to any exemption granted heretofore or hereafter to a Lewis County local municipality property should the Finance and Rules Committee determine that the exemption was unlawful or in contravention of the foregoing policy.

Section 3. The County of Lewis hereby grants an exemption from County taxes for Lewis County local municipal properties that meet the eligibility requirements set forth above as of March 1, 2022 and each tax year thereafter, unless amended, modified or rescinded by formal action of the Lewis County Board of Legislators.

Section 4. The Chairman, or the Vice-Chairman, of the Board of Legislators be and the same are hereby authorized to execute and deliver such documents, instruments or writings as may be necessary to effectuate the purpose of this Resolution upon such form as approved by the County Attorney.

Section 5. The Real Property Director shall cause a copy of this Resolution to be sent to the affected taxing units as soon as practical.

Section 6. The policy set forth in this Resolution shall be deemed to constitute the "agreement" of this governing board to authorize such exemptions to each Lewis County Town and Village who meet the criteria as provided in Real Property Tax Law § 406(3). This

Resolution shall remain in full force and effect unless or until it is amended or rescinded by formal action of the Board of Legislators.

Section 7. This Resolution shall take effect immediately.

WHEREAS, the residents of Lewis County have great respect, admiration, and the utmost gratitude for all who have selflessly served our country and this community in the Armed Forces; and

WHEREAS, Veterans continue to serve their community in the American Legion, Veterans of Foreign Wars, church groups, and other community agencies; and

WHEREAS, approximately 200,000 service members transition to civilian communities annually. Studies indicate that 44% to 75% of service members experience high levels of stress during transition from military to civilian life; and

WHEREAS, the Lewis County Board of Legislators appreciates the sacrifices our United States Military Personnel made while defending freedom, and believes specific recognition be accorded them to demonstrate the honor and support they deserve and have earned; and

WHEREAS, in advance of the upcoming Veterans Day holiday, and as part of a state-wide NYS Association of Counties and NYS County Veteran Service Officers' Association collaborative initiative known as "Operation Green Light", the Lewis County Board of Legislators encourages its citizens to focus attention on America's service men and women by displaying a green light for Veterans;

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. That in observance of Operation Green Light, the Lewis County Board of Legislators encourages its citizens in patriotic tradition to recognize the importance of honoring all those whose immeasurable sacrifices help to preserve freedom, and to let veterans know that they are seen, appreciated, and supported by displaying an interior or exterior green light in their business or residence the week around Veterans Day, i.e., November 7th through November 13th.

Section 2. That with designation as a Green Light for Military Service County, the Lewis County Board of Legislators hereby declares the week of November 7, 2021 through November 13, 2021 as a time to salute and honor the service and sacrifice of our men and women in uniform, and those transitioning from Active Service.

Section 3. That the Lewis County Board of Legislators directs that an exterior green light be displayed at the Lewis County Courthouse Building and any other County buildings capable of such lighting for the period of November 7, 2021 through November 13, 2021.

Section 4. That this Resolution shall take effect immediately.

RESOLUTION NO. 293 - 2021
RESOLUTION AUTHORIZING AND RATIFYING
TENTATIVE AGREEMENT AND FINAL CONTRACT
BETWEEN THE COUNTY OF LEWIS AND
LOCAL 825 OF THE CIVIL SERVICE
EMPLOYEES ASSOCIATION, INC. (GENERAL EMPLOYEES UNIT)

Introduced by Legislator Thomas Osborne, Chair of the Finance & Rules Committee.

WHEREAS, the existing contract between the County of Lewis and Local 825 of the Civil Service Employee's Association ("CSEA") for the County's general employees expired on December 31, 2020; and

WHEREAS, the negotiating teams representing the County of Lewis and the CSEA, reached a Tentative Agreement dated October 19, 2021, encompassing a summary of the changes agreed to for a three-year final Agreement to be effective January 1, 2021 through December 31, 2023; said Tentative Agreement ratified by the Local CSEA membership on November 2, 2021.

NOW, THEREFORE, BE IT RESOLVED as follows:

Section 1. That the Lewis County Board of Legislators hereby ratifies the agreement developed by the negotiating teams, accepted by the CSEA Local 825 for the County's general employees on November 2, 2021, and memorialized as the Tentative Agreement dated October 19, 2021.

Section 2. That the Chairman, or the Vice-Chairman of the Board of Legislators be and the same is hereby authorized to make, execute, seal and deliver the final contract between the County of Lewis and the Civil Service Employee's Association (General Employees Unit) based upon the terms of the Tentative Agreement, for the period January 1, 2021 through December 31, 2023, upon such form as may be approved by the County Attorney.

Section 3. That a copy of the final executed agreement shall be filed in the Office of the Clerk of the Board of Legislators; and that the County shall produce copies of such contract for distribution to employees of the CSEA Local 825 (General Employees Unit).

Section 4. That this resolution shall take effect immediately.

Moved by Legislator Virkler, seconded by Legislator Moroughan, and adopted on the 2nd day of November, 2021. Legislator Kulzer abstained.

OTHER BUSINESS (Continued):

Legislator Hathway recalled the original report that County Treasurer, Eric Virkler did on the Solar Production and gave credit to Chairman Dolhof for questioning the numbers which led to County Attorney Joan McNichol and County Treasurer, Eric Virkler looking into it further and realizing that the figures weren't correct. In speaking with Larsen Engineering, it was determined that the credits we received from National Grid are \$105,950.00 short and the credits owed to the county for low production from Green Skies is \$26,779.00. The total credits owed is almost the same amount that we have received for 2018, 2019 and 2020 combined. Moving forward Eric Virkler and Joan McNichol will work to make sure that we are getting the correct credits. He thanked Eric & Chairman Dolhof for both reporting and questioning the figures.

National Grid & Green Skies both agreed to the amounts without contention and the credits are already available. Legislator Chartrand along with several other fellow legislators thanked Legislator Hathway for his part in going through the figures and creating the spreadsheets used to show the shortage in credits. Chairman Dolhof personally thanked Legislator Hathway for driving the discussion and following up on this to make sure the county received all the credits.

Legislator Hathway gave recognition to all the individuals who assisted with the clean up of the Lyons Falls Pulp and Paper Mill. It took a team effort with lots of hard work to accomplish that task and it is greatly appreciated. Chairman Dolhof agreed with Legislator Hathway and felt very fortunate that the clean up was able to be completed even though it took ten or eleven years.

Legislator Chartrand made a motion at 5:36 p.m. to enter executive session regarding some potential property purchases and reasons why, after a short 3-minute recess, seconded by Legislator Osborne and carried.

Legislator Virkler made a motion at 6:20 p.m. to enter regular session, seconded by Legislator Hathway and carried.

There being no other business to come before the board Legislator Chartrand made a motion to adjourn at 6:20 p.m., seconded by Legislator Osborne and carried.
