




January 2025

- The Jefferson and Lewis County Community Services Departments have collaborated in the development of an RFP for Mobile Crisis Services. The RFP is #25-02 and can be accessed via Jefferson County's PlanetBids Vendor Portal. Responses to the RFP are due by 1PM on Friday, February 14th.
- Lewis County's JUUL Settlement funds have been requested from the Attorney General. The Department is working with CCSI and the Treasurer's Department to prepare for the funds.
- Director of Community Services (DCS) is working with the County Attorney, Lewis County
 Health System and other community partners to reissue DCS Designee status to individuals
 designated by the former director. Under Mental Hygiene Law 9.45, these designees are
 given the authority to direct the removal of a person (within their jurisdiction) to a 9.39
 hospital or Comprehensive Psychiatric Emergency Program (CPEP).





- On January 21st, DSS was notified by NYS OTDA (Office of Temporary and Disability Assistance) that regular HEAP benefit applications would no longer be accepted after the close of business the same day, emergency benefits would continue. The closing date was approximately 2 months earlier than previous years. OTDA the reopened to regular HEAP applications on January 25th creating widespread confusion. In January Lewis DSS received 95 regular HEAP applications and 203 Emergency benefit applications. Emergencies MUST be expedited as follows: Out of Heat within 18 hours and low on heat within 48 hours.
- DSS currently has 107 children enrolled in the Child Care subsidy program with expenditures averaging approximately \$65,000/ month. This is a 44.4 % increase over the same time last year.
- The Trinity Warming Center opened for daytime operation on January 30th. This
 center is open on Saturday and Sunday from 9AM-5PM and Monday, Thursday and
 Friday from 9AM-3PM. This center is funded through SnowBelt Housing and
 operated by NRCIL as an addition to the evening location funded by DSS using Code
 Blue funds.
- DSS participated in the annual HUD Point in Time Count of homelessness on January 23rd. All data obtained will be tabulated and reported by CARES NY who manages our local Continuum of Care called the Points North Housing Coalition. The count is held the same day across the nation to collect data and look at trends in homelessness. As of February 7, Lewis County DSS has 7 people housed in Temporary Housing using local motels and 3 people using the evening Warming Center regularly.
