



- Public Health started a Workplace Chronic Disease Self-Management Program for county employees at the end of March. The program filled quickly, and a wait list has been started for the next round. The program will teach employees with chronic condition healthy lifestyle habits to improve their health, wellbeing, and ultimately their job satisfaction and productivity. In addition to the health education each employee is receiving, they will receive a \$25 voucher for fruits and vegetables for each session they complete.
- Public Health brought in a National Active Classroom Trainer to train 100 staff members at Beaver River Central School. This is a Community Health Improvement Plan initiative to increase physical activity throughout the school day for students. Below is a picture of the training.



Starting on March 27,2025 you can apply for Child Support Services online at the following link: Home | Child Support Services. Paper applications are still available by downloading or contacting DSS at 315-376-5400 and we will mail one to you. A recent assessment of Lewis County Child Support Services sampled 9 performance areas with Lewis County receiving a rating of 96% efficiency far exceeding the Federal Standards of 78%.

Applications for HEAP; regular and emergency benefits; stop being accepted at COB on April 7, 2025. On March 21st, 3 temporary HEAP employees ended their work. HEAP Administrative allocations were released with Lewis County receiving \$104,477 a decrease of \$9,013 from the year prior.

DSS was directed by OTDA to terminate overpayments on SNAP cases that resulted from late reporting during the Pandemic. 34 cases totaling \$34,000 were written off.

Child Care subsidy allocations were released with no additional funding for Lewis County. Unfortunately, DSS had to establish a waitlist that currently has 8 cases.

The Lewis County Warming Center and Trinity Daytime center are remaining open from April 1- April 30 through funding provided by SnowBelt Housing.





- The Children's Home of Jefferson County (CHJC) has been selected as the Mobile Crisis provider for Jefferson and Lewis Counties. The contract will be presented at Jefferson County's April Board of Legislators Meeting for approval.
 - We received start up funds for this initiative from New York State Office of Mental Health and will be sending the funds to Jefferson County for disbursement to CHJC.
- Recruitment is underway for the next cohort of Getting Ahead. This cohort will be the first of six cohorts that will be funded by opioid settlement funds.
- Arranged evaluations from a CPL 730 Competency to Stand Trial request received from Lewis County Court in February. Reports were submitted to the court for final determination.
- Shawna Berry will join the department as the Mental Health Services Coordinator on April 8.
