## GENERAL SERVICES COMMITTEE May 20, 2025

Present: Andrea Moroughan, Chair; Josh Leviker, Vice-Chair; Herb Frost; Thomas Kalamas; and Jeff Nellenback.

Legislator Moroughan called the meeting to order at 1:31 p.m.

Legislator Moroughan moved to approve the April 15, 2025 committee meeting minutes as recorded, seconded by Legislator Frost, and carried.

## Lewis County Bridge Plan - John Reed, Lewis County Highway Superintendent

John Reed outlined a plan for the transfer of ownership of 12 town-owned bridges to the county, aimed at improving maintenance efficiency and alleviating financial burdens on municipalities. He noted the challenges towns face with aging infrastructure and the associated repair costs, emphasizing the need for additional funding to manage these responsibilities. The important of town resolutions in the ownership transfer process was highlighted, ensuring local input in the decision-making.

## Lewis County EMS - Josh Levesque, Director of Lewis County Search & Rescue

Josh Levesque presented alarming statistics regarding the EMS workforce, revealing a significant decline in certified providers and the closure of area ambulance services. He reported that 37% of EMS personnel plan to leave within five years, exacerbating staffing shortages. The discussion included the financial strain on volunteer services due to rising equipment costs and low Medicaid reimbursement rates. It was added that low wages and better job opportunities elsewhere are driving EMTs and paramedics out of the profession. A proposal for a four-crew EMS system to improve coverage and financial sustainability through town contracts and insurance reimbursements was discussed.

Financial challenges within the EMS system were further elaborated upon, with a projected funding gap of \$3.5 million against total expenses of approximately \$5.4 million indicated. The need for financial transparency and accountability was emphasized, with advocacy for elected officials to be included on the board overseeing EMS operations. The discussion also touched on the lack of local paramedics and the potential for a countywide study to assess the EMS system, although skepticism about its necessity was expressed.

Legislator Nellenback moved to authorize an RFP be created and published for a countywide study on Lewis County Emergency Management Services to find out what the best path forward is, seconded by Legislator Frost and carried.
