





August 2025

- On August 14th, the new Develon Wheeled Excavator was delivered. We made a downpayment of \$50,000 and financed the remaining \$148,922 through Republic First National. Our payments will be \$42,187.19 per year for four years.
- The clutches went out in both the 2016 and 2018 International tractors this month so we were down to just one tractor which resulted in using extra overtime hours.
- Our expenses significantly outweighed revenue this month due to having three payrolls \$72,499.02, the downpayment on the new excavator - \$50,000, the annual payment for the 2025 tractor -\$34,102.29 and vehicle repairs totaling \$9,985.49.
- The following charts show diesel fuel data that Solid Waste purchased from Lewis County Highway between August 2024 and July 2025. The data includes the amount paid, the number of gallons purchased and the price per gallon.



- Singing Waters water system inspection was completed by NYSDOH. We had no
 issues, and they said everything looked great. Reservations are on track with a plan
 to develop a marketing plan in development.
- The Lee Gulf Trail opened on August 18th. The crew has been doing a great job with the eleven new landowners that have signed agreements with the County from the Highmarket Wheelers Club. The landowner's appreciation lunch will be held on Saturday September 28th at noon at Tug Hill Hideaway.
- The NYS OPRHP Snowmobile Phase II application has been submitted. The Lewis County Area Snowmobile Association Meetings will start back up this month.
- Overall, the budget looks good, however the OHV Trail Permit revenue is currently at \$208,245.85 which is \$12,896.15 lower than last year to date. The current OHV bank account balance is \$153,242.32.

- The Interior Firefighter class is scheduled to start September 8 hosted at the Lowville Fire Station. There is a Rescue Technician Basic Class scheduled for November. There will also be an Emergency Vehicle Operations Course scheduled for November. In conjunction with Lewis County Cornell Coop Ext. there is a Grain Bin Rescue class scheduled for October 7.
- The fire police class completed in August at Croghan Fire Department. This class will enable fire department volunteers to safely and effectively route citizens around emergency scenes.
- Bob has had several meetings to help create the Jefferson/Lewis County Regional
 Hazardous Materials Response plan with ongoing biweekly conference calls.
- The EMT-Basic class started August 11th at Lewis County Search & Rescue with 12 students enrolled.
- A very important upgrade for the training tower has been completed, the electrical
 installation at the Fire Training tower. Improving lighting and safety for evolution
 and eliminating the need for generators. The monies were courtesy of the Garrett
 Loomis Foundation and had no budget impact for the office or departments.
