

Anyone convicted of an impaired driving offense in Lewis County is supposed to be Court mandated to attend a Victim Impact Panel. We had 14 participants attend the panel on 09/06/2025.
- •Senior Probation Officer Lisa Widrick, with her involvement with the Youth Bureau, helped plan and coordinate the Lewis County Night Out event at the Lewis County Fairgrounds on 09/05/2025. By all accounts, the event was a huge success in bringing law enforcement and first responders together with the community.
- •The Probation Department is hopeful that we will be attending a fall firearms range with the Lewis County Sheriff's Office later this month. We are extremely fortunate that our colleagues at the Sheriff's Office are willing to provide this important training for our department. We work closely with the Sheriff's Road Patrol and investigation units and look forward to more collaboration training with them in the future.





- The Lewis County Foster Parent Appreciation picnic was held on August 23rd at Whetstone Gulf State Park. Our Lewis County Foster Parents like the relaxed atmosphere a picnic provides while giving them time to network with other foster parents and children in our county.
- Federal HEAP funding remains unknown, with NYS assuming flat funding to be allocated by opening day on November 3rd. HEAP early applications were mailed to 538 Lewis County households. Should funding meet assumptions HEAP will no longer include the Clean and Tune Component, Heating Repair and Replacement or 2nd Emergency Benefits programs. When heating and utility emergencies happen people would then apply for Emergency Temporary Assistance, moving more of the cost to the local district.
- On August 19 and 20 all DSS employees received 1 full day of Productive Confrontation Communication training; employees were divided into 2 groups to maintain office hours and manage emergencies.
- Summer Youth Employment has mostly wrapped up with 1 youth remaining though September to expand all funds. 5 youth were hired by their private sector summer employer and continue to work for them.

- Mobile Crisis services are available to Lewis County residents, 24/7, 365 days a year. The phone number is (315) 405-0696.
 - CHJC has received interim designation of their mobile crisis services. This
 means they are now approved to be reimbursed by Medicaid Fee for Service
 and Medicaid Managed Care Plans.
- The Community Services Board is currently accepting applications for Round #2 of the Future Stories Fund (grant program using opioid settlement funds). Applications are open through Friday, September 5.
- The department received \$98,247 from NYS's settlement with JUUL for its role in the youth vaping epidemic. The funds are being distributed to every county, Board of Cooperative Educational Services (BOCES) and the five largest cities in the state to support programs that will reduce and prevent underage vaping. Over the next five years, we will receive five additional payments for a total of \$261,994.
- 730 Evaluations
 - One individual heading to an Intensive Treatment Option program through OPWDD on September 3. The County will be responsible for paying 50% of the per diem costs.
 - One pending 730 evaluation request. The County will be responsible for 100% of the evaluation costs.
