#### **ALL TRAILS CLOSE OCTOBER 14TH**

As we move into the fall, it's important for riders to be aware of upcoming trail closures across the Lewis County ATV Trail System.

- Areas J and F have already closed for the season.
- All other trails will remain open until October 14, 2025.

Seasonal closures are a vital part of protecting the trail system. They allow crews time to perform necessary maintenance, prevent long-term damage to the terrain, and respect agreements with private landowners who generously allow access to their property.

We ask all riders to follow posted closure signs and avoid entering closed trails. Riding on closed sections not only risks damage to the system but could also jeopardize access to private lands in future seasons.

Thank you for doing your part to keep the Lewis County ATV Trail System strong for years to come. Let's finish the 2025 season safely and responsibly!

## **Singing Waters Park**



As the riding season winds down and cooler weather approaches, the bathroom facilities at Singing Waters will close for the season on October 14, the day after Columbus Day. This seasonal closure helps protect the facilities during the winter months and ensures they are ready for use again when the trails reopen in the spring.

Riders are encouraged to plan ahead and make alternative arrangements while enjoying the trails in this area. We appreciate your understanding and cooperation as we take steps to maintain and preserve our facilities for future use.

# **Changes to Event Permit Law**

We would like to issue a correction regarding recent misinformation about the revised event permit law that was posted on the Lewis County ATV Trail System Facebook page. To ensure clarity for event organizers and participants, the following guidance applies:

- Any outdoor special motorized event held on a County or opted-in Town road with an expected attendance of 2,000 or more people must file for an event permit with the Lewis County Recreation, Forestry & Parks Department prior to the event.
- If attendance for a motorized event exceeds 2,000 or more people, all participants will also be required to purchase an annual Lewis County Trail Permit.
- While not required under Local Law, prior notice to the Director of Recreation, Forestry & Parks for motorized events expecting 250 to 1,999 participants is greatly appreciated.

Our department remains committed to supporting successful community events while ensuring compliance with county regulations. We apologize for the earlier miscommunication and appreciate the community's understanding.


