RESOLUTION AUTHORIZING A RENEWAL AGREEMENT BETWEEN THE COUNTY OF LEWIS AND TRANE BUILDING SERVICES

WHEREAS, the County of Lewis desires to renew an agreement with Trane Building Services for the purpose of providing maintenance services for Heating, Ventilating, and Air Conditioning ("HVAC") systems for the Department of Motor Vehicles and Board of Elections Building; and

WHEREAS, the Board of Legislators wishes to accept such services;

RESOLUTION AUTHORIZING PARKING LOT LEASE WITH BONNIE HODKINSON

Introduced by Legislator Andrea Moroughan, Chair of the General Services Committee.

WHEREAS, Bonnie Hodkinson is the owner of certain real property, located on the intersection of New York State Route 177 and Seven By Nine Road (County Route 69), a portion of which is used as a public parking area for recreational users executed on December 22, 1998, by her deceased parents; and

WHEREAS, the County desires to enter into a long-time lease with the owner to continue the designated area on her property as a public parking area for recreational users; and

NOW, THEREFORE, BE IT RESOLVED, as follows:,

Section 1. The Lewis County Board of Legislators hereby approves a lease between Bonnie Hodkinson and the County, through its Recreation, Forestry, and Parks Department for the purpose of using the following premises as recreational public parking, to commence upon execution of the agreement and continue for ninety-nine (99) years, unless terminated sooner by either party as set forth in the lease:

On a portion of the land owned by Bonnie Hodkinson located at the intersection of New York State Route 177 and Seven By Nine Road (County Route 69), identified as Tax Map No.: 171.04-03-11.1, and being approximately 1.1 acres.

Section 2. The Chair or the Vice-Chair be and the same is hereby authorized to execute and deliver such agreement upon such terms as may be approved by the County Attorney.

RESOLUTION TO AUTHORIZE DIRECTOR OF RECREATION, FORESTRY AND PARKS DEPARTMENT TO EXECUTE LANDOWNER ACCESS AGREEMENTS FOR PARKING LOTS TO BE USED BY PUBLIC RECREATION USERS

Introduced by Legislator Andrea Moroughan, Chair of the General Services Committee.

WHEREAS, outdoor recreational activities such as biking, hiking, snow-shoeing, snowmobiling and ATV/OHV riding are of critical importance to the Lewis County economy and its developmental growth for residents and visitors alike. Snowmobile riding is a premier winter recreational sport in Lewis County, attracting snowmobilers from near and far: and

WHEREAS, in order to provide parking areas for recreational users, the Recreation, Forestry and Parks Department has taken over securing landowner agreements for year-round recreational parking lot access in order to have vehicle off the roads while users enjoy recreational activities; and

WHEREAS, the Director of Recreation, Forestry and Parks seeks to have the Board authorize her to enter into landowner agreements/leases for year round parking areas open to the public for recreation uses; and

NOW, THEREFORE, BE IT RESOLVED, as follows:

Section 1. The Lewis County Board of Legislators hereby approves and authorizes the Director of Recreation, Forestry and Parks to enter into land access lease agreements with landowners in order to establish parking lots for access and use by recreation users in Lewis County.

Section 2. The Board of Legislators directs that the Director work with the County Attorney to develop the terms and conditions of said agreements/leases. The Director shall also maintain copies of said executed agreements and develop a document to be provided to the County Attorney and Clerk of the Board containing all relevant information pertaining to landowner names, locations, site of parking lots, lease term and renewals, and any other information and data deemed appropriate.

Section 3. The within resolution shall take effect immediately.

There will also be an Emergency Vehicle Operations Course scheduled for November. In conjunction with Lewis County Cornell Coop Ext. there is a Grain Bin Rescue class scheduled for October 7.

- The Lewis County Off Highway Vehicle Trail System will be closing on October 14th.
 Trail maintenance is being finalized with trail brushing continuing County parcels as weather allows. Seasonal Staff will be done for the season.
- Singing Waters facilities will be winterized and closed on October 16th. Day use will still be allowed but there will be no camping.
- There will be a Community Outreach OHV Trail System meeting on Wednesday, October 22nd at 6 pm at Tug Hill Hideaway, 1838 CR-47, West Leyden.
- The Lewis County Winter Recreation Master Plan is in the final draft form and will be reviewed this month and will be sent out to New York State Department of Environmental Conservation and Adirondack Park Agency for review before being finalized. We will be working with NYSDEC to use the remaining \$23,280 of the ADK Smart Growth Grant for signage.
- Overall, the budget looks great. We are \$50,303.77 over budget in reforestation revenue. The OHV Trail Permit revenue is currently at \$226,770.95 which is \$6,770.95 over budget for the year but \$13,326.96, lower than last year to date. The current OHV bank account balance is \$149,787.63.


