**Old Business**

Lewis County Board of Legislators passed resolution No. 138-2021 re-appointing members to Lewis County Youth Bureau Advisory Board on June 1, 2021.

**New Business**

-allocation of county funds \$5,000:

- MVP SPORT and Too Good for Violence requested \$4,850
- Lowville Library Continuing StoryWalk Project requested \$550
- UP! Coalition of Lewis County Photo Story Project requested \$1,070

After time for discussion, motion presented to fund Lowville Library and UP! Coalition fully and remaining funds to MVP SPORT/Too Good for Violence. Motion to approve made by Kallie Bauter, 2<sup>nd</sup> by Brian Finn. Eileen Mathys abstained. Carried. **Up!Coalition funded at \$1,070; Lowville Library at \$550 and MVP at \$3,380.**

-allocation of OCFS youth development funds \$23,399:

- MVP school-based program requested \$9,500

MVP representatives expressed the full amount of the OCFS funds would allow their program to continue at the current level as they have experienced loss of revenue. MVP will provide numbers and outcomes on their program; they are already required to do so. Brian Finn expressed that although MVP will not be in the high school at LACS next year their work benefits many students. Motion made to fund MVP at the requested \$9,500 and issue another RFP for the remaining \$13,899 with a return date in one month. Motion by Ada Simpson, 2<sup>nd</sup> by Ward Dailey. Carried. **MVP school-based program awarded \$9,500.** Deanna will send out new RFP for remaining \$13,899.

-election of officers

Motion to approve by Kallie Bauter, 2<sup>nd</sup> by Mike Leviker. Carried
