A local law providing for an increase in the salaries of the Commissioners of Election of the County of Lewis.

Be it enacted by the Board of Supervisors of the County of Lewis as follows:

Section 1. That the salaries of the Commissioners of Election of the County of Lewis be and the same hereby are increased over the present salaries and set at \$3,750.00, for each of the two election commissioners. That the above officers are to receive the above salaries until said salaries are duly amended by this Board, either by local law or a resolution duly adopted.

Section 2. That this local law shall take effect 45 days after the adoption and legal requirements being met.
