A local law providing for an increase in the salary of the  
Superintendent of Highways of the County of Lewis.

Be it enacted by the Board of Supervisors of the County  
of Lewis as follows:

Section 1. That the salary of the Superintendent of  
Highways of the County of Lewis be and the same hereby is set  
with a minimum of \$8,373.50 and a maximum of \$10,048.20,  
including annual increments of \$334.94. That the salary for  
calendar year 1966 be and the same hereby is set at \$10,048.20.  
That the above officer is to receive the above salary until  
said salary is duly amended by this Board, either by local  
law or a resolution duly adopted.

Section 2. That this local law shall take effect 45 days  
after the adoption and legal requirements being met.
