Introduced by Supervisor Paul Merz, Chairman of the County Officers and Employees Committee.

A local law providing for an increase in salaries of certain local officials.

Be it enacted by the Board of Supervisors of the County of Lewis as follows:

Section 1. That the salary of the Commissioners of Election of the County of Lewis be and the same hereby are increased over the present salaries and set at \$4,150.00, for each of the two election commissioners. That the above officers are to receive the above salaries until said salaries are duly amended by this Board, either by local law or a resolution duly adopted.

Section 2. That the salary of the County Attorney of the County of Lewis be and the same hereby is increased over the present salary and set at \$5,000.00. That the above officer is to receive the above salary until said salary is duly amended by this Board, either by local law or a resolution duly adopted.

Section 3. That the salary of each Supervisor, except the Chairman of the Board of Supervisors, of the County of Lewis, be and the same hereby are increased over the present salaries and set at \$1,500.00. That the above officers are to receive the above salaries until said salaries are duly amended by this Board, either by local law or a resolution duly adopted.

Section 4. That the salary of the Chairman of the Board of Supervisors of the County of Lewis be and the same hereby is increased over the present salary and set at \$2,000.00. That the above officer is to receive the above salary until said salary is duly amended by this Board, either by local law or a resolution duly adopted.

Section 5. That this local law shall take effect 45 days after the adoption thereof by the Board of Supervisors of the County of Lewis and the filing of this local law with the Secretary of State, provided no petition requiring a referendum is filed.
