LOCAL LAW (INTRODUCTORY IN 1967-4)

COUNTY OF LEWIS

Introduced by Supervisor Eugene Patterson, Chairman of the County Officers and Employees Committee.

A local law providing for an increase in salaries of certain local officials.

BE IT ENACTED by the Board of Supervisors of the County of Lewis as follows:

Section 1. That the salary of the Commissioners of Election of the County of Lewis be and the same hereby are increased over the present salaries and set at \$4,565.00, for each of the two election commissioners. That the above officers are to receive the above salaries until said salaries are duly amended by this Board, either by local law or a resolution duly adopted.

Section 2. That the salary of the Highway Superintendant of the County of Lewis be and the same hereby is set with a minimum of \$8,772.24 and a maximum of \$10,526.69, including annual increments of \$350.89. That the salary for calendar year 1968 be and the same hereby is set at \$10,526.69. That the above officer is to receive the above salary until said salary is duly amended by this Board, either by local law or a resolution duly adopted.

Section 3. That the salary of the District Attorney as Coroner of the County of Lewis be and the same hereby is increased over the present salary and set at \$1,050.00. That the above officer is to receive the above salary until said salary is duly amended by this Board, either by local law or a resolution duly adopted.

Section 4. That the salary of the Treasurer of the County of Lewis be and the same hereby is increased over the present salary and set at \$7,700.00. That the above officer is to receive the above salary until said salary is duly amended by this Board, either by local law or a resolution duly adopted.

Section 5. That the within local law shall take effect January 1st, 1968.

\*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or if there be none the chairman of the board of supervisors, the mayor of a city or village or the supervisor of a town, where such officer is vested with power to approve or veto local laws or ordinances.
