Introduced by Supervisor Eugene Patterson, Chairman of the County Officers and Employees Committee.

A local law providing for an increase in salaries of certain local officials.

BE IT ENACTED by the Board of Supervisors of the County of Lewis as follows:

Section 1. That the salary of the Treasurer of the County of Lewis be and the same hereby is increased over the present salary and set at \$8,301.00.

Section 2. That the salary of each Supervisor, except the Chairman of the Board of Supervisors, of the County of Lewis, be and the same hereby are increased over the present salaries and set at \$1,800.00.

Section 3. That the salary of the Chairman of the Board of Supervisors of the County of Lewis be and the same hereby is increased over the present salary and set at \$2,500.00.

Section 4. That the salary of the County Attorney of the County of Lewis be and the same hereby is increased over the present salary and set at \$6,000.00.

Section 5. That the salary of the Commissioners of Election of the County of Lewis be and the same hereby are increased over the present salaries and set at \$4,700.00 for each of the two election commissioners.

Section 6. That the salary of the Commissioner of Social Services of the County of Lewis be and the same hereby is increased over the present salary and set at \$9,015.00.

Section 7. That the salary of the Highway Superintendent of the County of Lewis be and the same hereby is set with a minimum of \$9,680.00 and a maximum of \$11,785.00, including annual increments of \$421.00. That the salary for calendar year 1969 be and the same hereby is set at \$11,785.00.

Section 8. That all of the above officers are to receive the above salaries until said salaries are duly amended by this

Board, either by local law or a resolution duly adopted.

Section 9. That the within local law shall take effect January 1st, 1969 or 45 days after the adoption and legal requirements being met, whichever event shall occur latest.
