BE IT ENACTED by the Board of Supervisors of the

Section 1. That the salary of the Commissioners
of Election of the County of Lewis be and the same hereby are
increased over the present salaries and set at \$4,900.00 for
each of the two election commissioners.

Section 2. That the salary of the Highway Super-
intendant of the County of Lewis be and the same hereby is
increased over the present salary and set at \$12,255.00.

Section 3. That the salary of the Commissioner
of Social Services of the County of Lewis be and the same hereby
is increased over the present salary and set at \$10,475.00.

Section 4. That all of the above officers are to
receive the above salaries until said salaries are duly amended
by this Board, either by local law or a resolution duly adopted.

Section 5. That the within local law shall take
effect January 1st, 1970 or 45 days after the adoption and legal
requirements being met, whichever event shall occur latest.

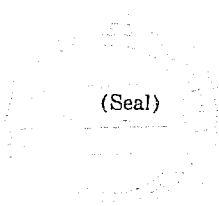
