Introduced by Legislator Sam Villanti, Chairman of the County Officers and Employees Committee.

A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the salary of one of the Commissioners of Election (Democratic Member) of the County of Lewis be and the same hereby is increased over the present salary and set at \$5,100.00.

Section 2. That the salary of the County Attorney of the County of Lewis be and the same hereby is increased over the present salary and set at \$6,650.00.

Section 3. That the salary of the Commissioner of the Lewis County Department of Social Services be and the same hereby is increased over the present salary and set at \$11,295.00.

Section 4. That the salary of the Highway Superintendent of the County of Lewis be and the same hereby is increased over the present salary and set at \$13,150.00

Section 5. That the salary of the County Judge and Surrogate Judge of the County of Lewis be and the same hereby is increased over the present salary and set at \$25,750.00.

Section 6. That all of the above officers are to receive the above salaries until said salaries are duly amended by this Board, either by local law or a resolution duly adopted.

Section 7. That the within local law shall take effect January 1st, 1971, or 45 days after the adoption and legal requirements being met, whichever event shall occur latest.
