A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the salaries of the Two Commissioners of Election of the County of Lewis be and the same hereby are increased over the present salaries and each salary is set at \$5,600.00.

Section 2. That the salary of the Highway Superintendant of the County of Lewis be and the same hereby is increased over the present salary and is set at \$18,637.00.

Section 3. That the salary of the County Attorney of the County of Lewis be and the same hereby is increased over the present salary and is set at \$7,832.00.

Section 4. That the salary of the Property Tax Director of the County of Lewis be and the same hereby is increased over the present salary and is set at \$8,598.00.

Section 5. That the above officers are to receive the above salaries until said salaries are duly amended by this Board, either by local law or a resolution duly adopted.

Section 6. That the within local law shall take effect January 1st, 1973, or 45 days after the adoption and legal requirements being met, whichever event shall occur latest.

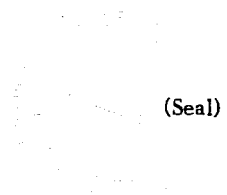
