A LOCAL LAW RELATING TO ELIGIBILITY FOR APPOINTMENT OF MEMBERS
OF LEWIS COUNTY BOARD OF LEGISLATORS TO CERTAIN PUBLIC OFFICES,
BOARDS AND COMMISSIONS.

BE IT ENACTED by the Board of Legislators of the County
of Lewis as follows:

Section 1. Pursuant to the provisions of the Municipal
Home Rule Law, §10, subd. 1.a.(1) whenever a vacancy shall occur
or exist in any unsalaried county office, board or commission,
a person otherwise qualified, who is a member of the Lewis
County Board of Legislators, may be appointed to fill the
vacancy without resigning his position as County Legislator.

Section 2. That the within local law shall become
effective immediately upon all legal requirements being met.
