A LOCAL LAW CREATING THE OFFICE OF PUBLIC DEFENDER IN AND FOR
THE COUNTY OF LEWIS AND OTHERWISE TREATING OF THE POSITION OF
PUBLIC DEFENDER.

Be it enacted by the Board of Legislators of the
County of Lewis as follows:

Section 1. That Local Law No. 3 of the Year 1966,
being a local law creating the office of Public Defender in and
for the County of Lewis and otherwise treating of the position
of Public Defender, be and the same hereby is repealed.

Section 2. That the office of Public Defender in and
for the County of Lewis be and the said office hereby is created.

Section 3. The duties of such Public Defender are such
as defined in §717 of the County Law and any acts amendatory thereto.

Section 4. The compensation and term of office of such
Public Defender shall be fixed by the Board of Legislators pursuant
to Article 18A of the County Law and any acts amendatory thereto.

Section 5. Subject to the approval of the Board of
Legislators the Public Defender may appoint as many assistant
attorneys, clerks, investigators, stenographers and other employees
as he may deem necessary and as shall be authorized by such Board.

Section 6. That the first appointment to this office
of Public Defender under this local law shall be made as of the
effective date of such local law and that all succeeding appoint-
ments shall be for two year terms beginning on the 1st days of
January in even numbered years.

Section 7. That the within local law shall take effect
January 1st, 1976.
