A LOCAL LAW AUTHORIZING THE PAYMENT OF MOVING EXPENSES INTO  
LEWIS COUNTY OF NEWLY APPOINTED PHYSICIANS AS EMPLOYERS OF THE  
LEWIS COUNTY GENERAL HOSPITAL.

BE IT ENACTED by the Board of Legislators of the County  
of Lewis as follows:

Section 1. Payment or reimbursement, in whole or in  
part, to newly appointed physicians as employees of Lewis  
County General Hospital, of their expenses in moving into Lewis  
County to assume employment with said Lewis County General  
Hospital is hereby authorized, subject to the approval of the  
Board of Managers of said Hospital and to such conditions and  
requirements as it may impose thereon.

Section 2. That this local law shall take effect  
immediately.

4. I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the County of was duly passed by the on 19 and was approved by the Elective Chief Executive Officer on 19. Such local law being subject to a permissive referendum and no valid petition requesting such referendum having been filed, said local law was deemed duly adopted on 19, in accordance with the applicable provisions of law.

\*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or if there be none the chairman of the board of supervisors, the mayor of a city or village or the supervisor of a town, where such officer is vested with power to approve or veto local laws or ordinances.
