A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN
LOCAL OFFICIALS.

BE IT ENACTED by the Board of Legislators of the
County of Lewis as follows:

Section 1. That the salary of the Commissioner of
Social Services of the County of Lewis be and the same hereby
is increased over the present salary and is set at \$16,500.00.

Section 2. That the salary of the Two Commissioners
of Election of the County of Lewis be and the same hereby are
increased over the present salaries and are set at \$6,500.00 each.

Section 3. That the salary of the Superintendent
of Highways of the County of Lewis be and the same hereby is
increased over the present salary and is set at \$19,500.00.

Section 4. That the above officials are to receive
the above salaries until said salaries are duly amended by this
Board, either by local law or resolution duly adopted.

Section 5. That the within local law shall take
effect January 1st, 1976, or 45 days after the adoption and
legal requirements being met, whichever event shall occur latest.
