A LOCAL LAW EXTENDING THE COVERAGE OF VOLUNTEER FIREMEN UNDER WORKMENS COMPENSATION.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the intent and purpose of this local law is to extend the coverage under workmen's compensation of volunteer firemen who are members of a fire company within the County of Lewis.

Section 2. That in addition to the coverage afforded under §5 of the Volunteer Firemen's Benefit Law the duties and activities in relation to which benefits shall be paid and provided for under Lewis County Self-Insurance Plan to volunteer firemen who are members of a fire company located within the County of Lewis shall extend to the following situations:

- (a) While within the County, or an adjoining county, and pursuant to orders or authority, assisting or working in connection with a search for lost humans, including necessary travel to and returning therefrom directly in connection therewith.
- (b) While within the County, or in an adjoining county, pursuant to a valid contract for fire services, and pursuant to orders or authority, assisting County residents with water problems, including lack of water or surplusage of water, including necessary travel to and returning therefrom directly in connection therewith.
- (c) While within the County, or in an adjoining county pursuant to a valid contract for fire services, and pursuant to orders or authority, assisting in preparing for or being involved with the aftermath of any emergency situations concerning (a) damages or events connected with the elements or acts of God, or (b) damages or events caused by the acts of man, including necessary travel to and returning therefrom directly in connection therewith.

Section 3. That the within local law shall take effect immediately.
