A LOCAL LAW WITH REFERENCE TO THE PREPARATION OF I D CARDS BY  
THE SHERIFF OF THE COUNTY OF LEWIS.

Be it enacted by the Board of Legislators of the County  
of Lewis as follows:

Section 1. The Sheriff of the County of Lewis be and  
he hereby is authorized to prepare and issue I D cards.

Section 2. That the charge for such preparation, together  
with photographing, laminating and such other services, shall be  
\$3.00.

Section 3. That there hereby is delegated to the Board  
of Legislators of the County of Lewis the power to adopt resolu-  
tions changing, altering, adding to or deleting from the above  
stated services and fees and to promulgate rules and regulations  
for fully administering the provisions hereof.

Section 4. That the within local law shall take effect  
immediately upon all legal requirements being met.
