A LOCAL LAW PROVIDING FOR CONTRACTS FOR SERVICES OF PHYSICIANS.

Introduced by Legislator Irving Kraeger, Chairman of the Hospital Committee.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. It is the intent of this Local Law to promote the recruitment of licensed physicians and make such physicians available for medical care and treatment for both Lewis County General Hospital and residents of the County of Lewis generally.

Section 2. The County of Lewis, through the Board of Managers of Lewis County General Hospital, may contract on a periodic basis, for terms not to exceed one year at a time, for the services of licensed physicians to render and be available for medical care and treatment for both Lewis County General Hospital and the residents of Lewis County in general.

Section 3. That the County of Lewis is authorized and empowered to appropriate the sums required to be paid under the terms of such contracts and to raise the amount thereof by taxation

Section 4. That the implementation of this local law and the making and formulation of rules and regulations in connection therewith is hereby delegated to a committee consisting of the Chairman of the Hospital Committee of the Board of Legislators and two members of the Board of Managers of Lewis County General Hospital appointed by said Board of Managers.

Section 5. That in the interests of more fully securing medical coverage for both the residents of the County of Lewis and Lewis County General Hospital this local law may be used in conjunction with Local Law No. 1-1977, County of Lewis being "A LOCAL LAW WITH REFERENCE TO THE RECRUITMENT AND MAINTENANCE OF PHYSICIANS AND THE EXPENDITURE OF COUNTY FUNDS IN CONNECTION THEREWITH."

Section 6. That this local law shall take effect immediately upon all legal requirements being met.
