A LOCAL LAW PROVIDING FOR AN INCREASE IN THE SALARIES OF THE
PUBLIC DEFENDER AND TREASURER.

BE IT ENACTED by the Board of Legislators of the
County of Lewis as follows:

Section 1. That the salary of the Public Defender
of the County of Lewis be and the same hereby is increased over
her present salary and is set at the sum of \$10,368.

Section 2. That the salary of the Treasurer of the
County of Lewis be and the same hereby is increased over his
present salary and is set at the sum of \$16,200.

Section 3. That the Public Defender and Treasurer
are to receive the above salaries until said salaries are duly
amended by this Board, either by local law or resolution duly
adopted.

Section 4. That the within local law shall take effect
January 1st, 1981, or 45 days after the adoption and legal
requirements being met, whichever event shall occur latest.
