A LOCAL LAW PROVIDING FOR EXEMPTION OF THE COUNTY OF LEWIS AND  
OTHERS FROM FEES OF LEWIS COUNTY SHERIFF.

BE IT ENACTED by the Board of Legislators of the County  
of Lewis as follows:

Section 1. Notwithstanding any other general, special  
or local law, rule or regulation relating to fees of the Sheriff  
of the County of Lewis said Sheriff shall not charge or collect  
any fee from the County of Lewis, the County Attorney, the Public  
Defender, the District Attorney, or any agency, department or  
officer thereof, or from the Family Court, Surrogate's Court and  
County Court of the County of Lewis, for any services rendered in  
the receiving of and service and levying of any papers, court  
orders, summons, executions or other legal documents, without being  
restricted to the aforesaid categories.

Section 2. That this local law does not apply to  
Sheriff's poundage or any other income accruing after the service  
of any papers, court orders, summons, executions or other legal  
documents, which said poundage or any other income he is to  
continue to be entitled to and collect.

Section 3. That the Sheriff of the County of Lewis shall  
not charge any fee to the County of Lewis, the County Attorney,  
the Public Defender, the District Attorney, or any agency, depart-  
ment or officer thereof, or the Family Court, Surrogate's Court and  
County Court of the County of Lewis, for furnishing a transcript,  
certificate or copy of any paper, document or proceeding to be  
used for official purposes.

Section 4. That the within local law shall take effect  
upon all legal requirements being met.
