A LOCAL LAW WITH REFERENCE TO TERMS OF OFFICE ON LEWIS COUNTY COMMUNITY MENTAL HEALTH, DEVELOPMENTAL DISABILITIES AND ALCOHOLISM SERVICES BOARD.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. The following Legislative findings are made: This County Legislature is cognizant of §41.11, subd. (d) of the Mental Hygiene Law which, in part, provides that no person may serve as a member of a board of a subcommittee for more than two terms consecutively on the Lewis County Community Mental Health, Developmental Disabilities and Alcoholism Services Board, unless otherwise provided by local law. There are circumstances in which it is to the best interests of our County that some individuals, because of their expertise or other important factors, serve more than two consecutive terms. This Board elects to take advantage of its right to adopt a local law in connection herewith.

Section 2. That any person may serve as a member of a board of a subcommittee (Lewis County Community Mental Health, Developmental Disabilities and Alcoholism Services Board) for more than two terms consecutively, upon a majority approving vote of the entire membership of the Lewis County Board of Legislators.

Section 3. That the within local law shall take effect immediately upon all legal requirements being met.
