A LOCAL LAW AUTHORIZING THE PAYMENT OF MOVING EXPENSES INTO LEWIS COUNTY OF NEWLY APPOINTED INDIVIDUALS AS OFFICERS OR EMPLOYEES OF THE COUNTY OF LEWIS.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. Payment or reimbursement, in whole or in part, to newly appointed individuals as officers or employees of the County of Lewis, of their expenses in moving to Lewis County to assume employment with said County of Lewis is hereby authorized, subject to the approval of the Board of Legislators and to such conditions and requirements as it may impose thereon.

Section 2. This local law shall apply to any moving expenses actually incurred and accrued for services rendered beginning with March 1st, 1988.

Section 3. That this local law shall take effect immediately.

Such local law was submitted to the people by reason of a mandatory referendum, and received the affirmative vote of a majority of the qualified electors voting thereon at the special election held on 19, in accordance with the applicable provisions of law.

4. (Subject to permissive referendum, and final adoption because no valid petition filed requesting referendum.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19. County of Lewis was duly passed by the Board of Legislators on 19 and was approved and repassed after disapproval by the Elective Chief Executive Officer*. Such local law being subject to a permissive referendum and no valid petition requesting such referendum having been filed, said local law was deemed duly adopted on 19, in accordance with the applicable provisions of law.

*Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis or, if there be none, the chairman of the county legislative body, the mayor of a city or village or the supervisor of a town where such officer is vested with power to approve or veto local laws or ordinances.
