A LOCAL LAW WITH REFERENCE TO DEPUTY BUDGET OFFICER (PART-TIME).

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That by this local law there is hereby created and established in the County of Lewis the position of Deputy Budget Officer (part-time).

Section 2. That the Deputy Budget Officer is authorized to act generally for and in place of the Budget Officer and shall perform such other duties as may be designated by the Budget Officer or the Board of Legislators.

Section 3. That this local law shall take effect immediately.
