## COUNTY OF LEWIS

## A LOCAL LAW WITH REFERENCE TO MERCY HOSPITAL.

Introduced by Legislator Clifford Reinhard, Chairman of the Board of Legislators.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. This Board of Legislators makes the following determinations: The Military Assistance to Safety and Traffic Program (MAST) has just successfully completed its first year of operation and has proven to be a life saving service to the residents of the North Country and residents of Lewis County. The MAST Program was originated through the co-operative efforts of the U. S. Army, Mercy Hospital, St. Lawrence, Lewis and Jefferson Counties, with the coordination of the Northern New York Emergency Services Council and the support of the Fort Drum Steering Council. This successful partnership has continued to grow with the program, which has been expanded to include Oswego County. At the present time Mercy Hospital needs assistance in the amount of \$90,000 with apportionments and contributions having been computed as follows:

That the funds authorized by this local law are for use, in connection with expenditures from other counties as above set forth, in the finalization and completion of a helipad at Mercy Hospital for use by, among others, the residents of Lewis County. It is of high importance to this County and the residents thereof, and for the health, welfare and safety of such residents, that such helipad be finalized and that the contributions herein be authorized. The within local law relates to the property, affairs or government of this Board of Legislators and to the health, welfare and wellbeing of its residents.

Section 2. That the Board of Legislators be and it hereby is authorized to expend a sum not exceeding \$10,000 as a payment towards the finalization of the helipad program at Mercy Hospital.

Section 3. That the Chairman of the Board of Legislators be and he hereby is authorized to make, execute and deliver any and all papers and documents in connection herewith.

Section 4. That the Treasurer of the County of Lewis be and he hereby is authorized to expend a sum not to exceed \$10,000 upon the direction of the Chairman of the Board of Legislators.

Section 5. That the within local law shall take effect immediately upon all legal requirements being met.
