A LOCAL LAW WITH REFERENCE TO TAXATION WITHIN THE COUNTY OF LEWIS.

This Board of Legislators makes the following determinations: On January 1st, 1991 State Legislation will amend the real property tax law in relation to the enforcement of the collection of delinquent real property taxes, and to repeal certain provisions thereof relating thereto. This proposal will repeal the provisions of the Real property Tax Law relating to tax enforcement (primarily Articles 10 and 11 and Article 11, Title 3) and enact a new system of tax enforcement (to be a new Article 10). This County is operating under Chapter 896 of the Laws of 1945 as amended by Chapter 191 of the Laws of 1947 and Chapter 302 of the Laws of 1949. Further this County is interested in continuing the aforesaid law affecting the County of Lewis and in particular determines to keep its own tax enforcement procedure.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That this Board hereby determines that it will continue to operate under Chapter 896 of the Laws of 1945 as amended by Chapter 191 of the Laws of 1947 and Chapter 302 of the Laws of 1949.

Section 2. That in particular, but not in limitation thereof, this Board determines that it retain its enforcement of delinquent taxes as now exists within the above referred to legislation affecting Lewis County.

Section 3. That the within local law shall take effect immediately upon all legal requirements being met.
