A LOCAL LAW WITH REFERENCE TO SOLAR AND WIND ENERGY SYSTEMS EXEMPTIONS

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That notwithstanding the provisions of subdivision 2 of Section 487 of the Real Property Tax Law, or any other provisions under said Section 487, no exemption shall be applicable with respect to any solar or wind energy system constructed subsequent to January 1, 1991 or the effective date of this local law, whichever is later.

Section 2. That the within local law shall be effective immediately upon all legal requirements being met.
