Section 1. That the salaries of the following officials of the County of Lewis be and the same hereby are increased over their present salaries and are set forth at the following:

Section 2. That all salaries herein affected, upon the adoption and consummation of this local law, shall be effective as of January 1st, 1993.

Section 3. That the above officials are to receive the above salaries until said salaries are duly amended by this Board.

Section 4. That the within local law shall take effect January 1st, 1993, or 45 days after the adoption and all legal requirements being met, whichever event shall occur latest.




