A LOCAL LAW OPTING OUT OF THE PROVISIONS OF CHAPTER 602 OF THE LAWS OF 1993.

BE IT ENACTED by the Board of Legislators of the County of Lewis, as follows:

Section 1. The County of Lewis has special legislation for the collection of delinquent real property taxes pursuant to the provisions of Chapter 896 of the Laws of 1945, as amended by Chapter 191 of the Laws of 1947, and Chapter 302 of the Laws of 1949.

Section 2. Chapter 602 of the Laws of 1993 adopted new procedures for the collection of delinquent real property taxes which are applicable to all counties within New York State, except counties with special acts relating to tax enforcement who adopt a local law "opting out" of the provisions of Chapter 605 of the Laws of 1993.

Section 3. The County of Lewis hereby elects to continue with the collection of delinquent real property taxes pursuant to the provisions of Chapter 896 of the Laws of 1945, as amended by Chapter 191 of the Laws of 1947, and Chapter 302 of the Laws of 1949.

Section 4. This Local Law shall take effect upon filing with the Secretary of State.
