**A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS.**

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the salaries of the following officials of the County of Lewis be and the same hereby are increased over their present salaries and are set forth at the following:

Superintendent of Highways (70%)	-	\$ 30,448.00
Commissioner of Social Services	-	\$ 43,062.00
Real Property Tax Director	-	\$ 30,217.00
Commissioners of Election (each)	-	\$ 16,056.00
County Attorney	-	\$ 29,705.00
Public Defender	-	\$ 26,042.00
District Attorney	-	\$ 35,571.00
County Clerk	-	\$ 31,821.00
County Treasurer	-	\$ 35,229.00
Sheriff	-	\$ 37,514.00

Section 2. That all salaries herein affected, upon the adoption and consummation of this Local Law, shall be effective as of January 1st, 1995.

Section 3. That the above officials are to receive the above salaries until said salaries are fully amended by this Board.

Section 4. That the within Local Law shall take effect 45 days after the adoption and all legal requirements being met.
