Local Law No. 3 of the Year 1997

A Local Law Providing for an Increase in Salaries of Certain Local Officials.
(Insert Title)

Be it enacted by the **Lewis County Board of Legislators** of the **County of Lewis**, as follows:

LOCAL LAW NO. 3 - 1997 COUNTY OF LEWIS

Introduced by Chairman of the Board of Legislators, Jack T. Bush.

A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the salaries of the following officials of the County of Lewis be and the same hereby are increased over their present salaries and are set forth at the following:

Superintendent of Highways (70%)	-	\$31,500.00
Commissioner of Social Services	-	\$47,056.00
Real Property Tax Director	-	\$33,020.00
Commissioners of Election (each)	-	\$12,360.00
Public Defender	-	\$28,457.00
District Attorney	-	\$38,869.00
County Clerk	-	\$34,772.00
County Treasurer	-	\$38,496.00
County Sheriff	-	\$40,992.00

Section 2. That all salaries herein affected, upon the adoption and consummation of this Local Law, shall be effective as of January 1st, 1998.

Section 3. That the above officials are to receive the above salaries until said salaries are duly amended by this Board.

Section 4. That the within Local Law shall take effect 45 days after the adoption and all legal requirements being met.

4. (Subject to a Permissive Referendum and Final Adoption Because No Valid Petition was Filed Requesting Referendum.)

I hereby certify that the Local Law annexed hereto, designated as Local Law No. _____ of 19__, of the County, City, Town, Village of _____ was duly passed by the _____ on _____, 19__, and was approved/not disapproved/repassed after disapproval by the _____ on _____, 19__. Such Local Law was subject to permissive referendum and no valid petition requesting such referendum was filed as of _____, 19__, in accordance with the applicable provisions of law.

* Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis, or if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto Local Laws or Ordinances.

5. (City Local Law Concerning Charter Revision Proposed by Petition.)


