Local Law No. 1 of the Year 2000

A Local Law Providing for an Increase in Salaries of Certain Local Officials.
(Insert Title)

Be it enacted by the **Lewis County Board of Legislators** of the **County of Lewis**, as follows:

LOCAL LAW NO. 1 - 2000 COUNTY OF LEWIS

Introduced by Chairman of the Board of Legislators, Ralph K. Farney.

A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the salaries of the following officials of the County of Lewis be and the same hereby are increased over their present salaries and are set forth at the following:

Superintendent of Highways (70%)	-	\$42,967.00
Commissioner of Social Services	-	\$50,000.00
Real Property Tax Director	-	\$35,031.00
Commissioners of Election (each)	-	\$13,113.00

Section 2. That all salaries herein affected, upon the adoption and consummation of this Local Law, shall be effective as of January 1st, 2000.

Section 3. That the above officials are to receive the above salaries until said salaries are duly amended by this Board.

Section 4. That the within Local Law shall take effect 45 days after the adoption and all legal requirements being met.

Such Local Law was submitted to the people by reason of a mandatory/permissive referendum, and received the affirmative vote of a majority of the qualified electors voting thereon at the general/special/annual election held on _____, 19__, in accordance with the applicable provisions of law.

4. (Subject to a Permissive Referendum and Final Adoption Because No Valid Petition was Filed Requesting Referendum.)

I hereby certify that the Local Law annexed hereto, designated as Local Law No. 1 of 2000, of the County of Lewis was duly passed by the Lewis County Board of Legislators on December 7, 1999. Such Local Law was subject to permissive referendum and no valid petition requesting such referendum was filed as of January 24, 2000, in accordance with the applicable provisions of law.

* Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis, or if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto Local Laws or Ordinances.

5. (City Local Law Concerning Charter Revision Proposed by Petition.)


I hereby certify that the Local Law annexed hereto, designated as Local Law No. _____ of 19__, of the City of _____ having been submitted to referendum pursuant to the provisions of Section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special/general election held on _____, 19__, became operative.

6. (County Local Law Concerning Adoption of Charter.)

I hereby certify that the Local Law annexed hereto, designated as Local Law No. _____ of 19__, of the County of _____, State of New York, having been submitted to the electors at the General Election of November _____, 19__, pursuant to the subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.


