A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. That the salaries of the following officials of the County of Lewis be and the same hereby are increased over their present salaries and are set forth at the following:

Superintendent of Highways (90%)	-	\$44,256.00
Commissioner of Social Services	-	\$51,500.00
Real Property Tax Director	-	\$36,082.00
County Attorney	-	\$42,000.00
Public Defender	-	\$41,200.00
County Clerk	-	\$37,996.00
County Treasurer	-	\$42,067.00
County Sheriff	-	\$48,410.00
