Local Law No. 4 of the Year 2001

A Local Law entitled “**DESIGNATING THE OFFICE OF DISTRICT ATTORNEY AS A FULL-TIME POSITION.**”

Be it enacted by the Lewis County Board of Legislators of the County of Lewis, as follows:

Section 1. That the position of District Attorney of the County of Lewis is hereby designated as full-time.

Section 2. In accordance with Subdivision 8 of County Law Section 700, the District Attorney shall give his whole time to his duties and shall not engage in the practice of law, act as an arbitrator, referee or compensated mediator in any action or proceeding or matter or engage in the conduct of any other profession or business which interferes with the performance of his duties as District Attorney.

Section 3. That the salary of the District Attorney is fixed as the amount paid to the County Judge of Lewis County.

Section 4. That the within Local Law shall take effect 45 days after its adoption in accordance with Municipal Home Rule Law Section 24 and all legal requirements being met.

I hereby certify that the Local Law annexed hereto, designated as Local Law No. 4 of 2001, of the County of Lewis was duly passed by the Lewis County Board of Legislators on December 21, 2000. Such Local Law was subject to permissive referendum and no valid petition requesting such referendum was filed as of February 5, 2001, in accordance with the applicable provisions of law.

* Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis, or if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto Local Laws or Ordinances.

5. (City Local Law Concerning Charter Revision Proposed by Petition.)


