## **County of Lewis**

Local Law No. 2 of the Year 2003

**A Local Law known as “A Local Law to Repeal Local Law No. 3 of the Year 1987, and Resolution 71-1989 and to abolish reimbursement of educational expenses for Lewis County employees”.**

BE IT ENACTED by the Board of Legislators of the County of Lewis, as follows:

**SECTION 1.** LEGISLATIVE FINDINGS: The Board of Legislature finds that Local Law No. 3-1987, which provides for reimbursement of educational expenses for Lewis County employees, was originally intended to offer to Lewis County employees the opportunity to obtain training and technical education in job-related functions in order to improve job performance and productivity. The Local Law and the policies that emanated therefrom have been misunderstood by the employees to authorize obtaining reimbursement for higher education leading to undergraduate and graduate degrees. The Board further finds that in light of the misunderstanding surrounding the intent of Local Law No. 3-1987 and the current budgetary and fiscal constraints existing in Lewis County, the legislative policy of providing reimbursement of educational expenses is no longer prudent.

**SECTION 2.** The Board of Legislators hereby repeals Local Law No. 3-1987 in its entirety.

**SECTION 3.** The Board of Legislators further repeals Resolution 71-1989 and any and all administrative policies that may now exist in reference to reimbursing educational expenses for Lewis County employees.

**SECTION 4.** This Local Law shall take effect immediately.


