A Local Law Establishing Filing and Publication Requirements for Notices of Adoption of Local Laws for the County of Lewis.

Be it enacted by the **Lewis County Board of Legislators** of the **County of Lewis**, as follows:

LOCAL LAW NO. 1 - 2004
COUNTY OF LEWIS

Introduced by the Chairman of the Board of Legislators, Dennis M. Mastascusa.

**A LOCAL LAW ESTABLISHING FILING AND PUBLICATION
REQUIREMENTS FOR NOTICES OF ADOPTION OF LOCAL LAWS FOR THE
COUNTY OF LEWIS.**

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

SECTION 1. TITLE

This Local Law shall be known as the “Local Law Establishing Filing and Publication Requirements for Notices of Adoption of Local Laws for the County of Lewis”.

SECTION 2. AUTHORITY

This Local Law is enacted pursuant to the Home Rule Authority found in Municipal Home Rule Law §20 et. seq.

SECTION 3. POST-ADOPTION NOTICE REQUIREMENTS.

Notwithstanding any statute, local law, ordinance, or resolution to the contrary, upon the adoption of a local law by the Board of Legislators the following filing and publication requirements shall apply:

1. Within twenty (20) days of the adoption of a local law, the Clerk of the Board of Legislators shall cause a certified copy of the adopted local law to be filed with the County Clerk and in the Office of the Secretary of State in accordance with Municipal Home Rule Law §27.
2. No further publication or notice of an adopted local law shall be required.

SECTION 4. REPEALER

All previous local laws to the contrary are hereby deemed repealed.

SECTION 5. EFFECTIVE DATE

This Local Law shall take effect forty-five (45) days after the adoption hereof and all legal requirements having been met.

I hereby certify that the Local Law annexed hereto, designated as Local Law No. _____ of 20___, of the County, City, Town, Village of _____ was duly passed by the _____ on _____, 20___, and was approved, not disapproved, repassed after disapproval, by the _____ on _____, 20___ . Such Local Law was submitted to the people by reason of a mandatory/permissive referendum, and received the affirmative vote of a majority of the qualified electors voting thereon at the general/special/annual election held on _____, 20___, in accordance with the applicable provisions of law.

4. (Subject to a Permissive Referendum and Final Adoption Because No Valid Petition was Filed Requesting Referendum.)

I hereby certify that the Local Law annexed hereto, designated as Local Law No. 1 of 2004, of the County of Lewis was duly passed by the Lewis County Board of Legislators on December 2, 2003. Such Local Law was subject to permissive referendum and no valid petition requesting such referendum was filed as of January 16, 2004, in accordance with the applicable provisions of law.

* Elective Chief Executive Officer means or includes the chief executive officer of a county elected on a county-wide basis, or if there be none, the chairman of the county legislative body, the mayor of a city or village, or the supervisor of a town where such officer is vested with the power to approve or veto Local Laws or Ordinances.

5. (City Local Law Concerning Charter Revision Proposed by Petition.)


I hereby certify that the Local Law annexed hereto, designated as Local Law No. _____ of 20__, of the City of _____ having been submitted to referendum pursuant to the provisions of Section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special/general election held on _____, 20__, became operative.

6. (County Local Law Concerning Adoption of Charter.)

I hereby certify that the Local Law annexed hereto, designated as Local Law No. _____ of 20__, of the County of _____, State of New York, having been submitted to the electors at the General Election of November _____, 20__, pursuant to the subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.

I further certify that I have compared the preceding Local Law with the original on file in this office and that the same is a correct transcript therefrom and of the whole of such original Local Law, and was finally adopted in the manner indicated in Paragraph 4, above.




