**A LOCAL LAW AMENDING LOCAL NO. 4 - 1956, COUNTY OF LEWIS,
AS AMENDED BY LOCAL LAW NO. 2-2000, BEING A LOCAL LAW
ENUMERATING RULES AND REGULATIONS OF THE ADMINISTRATION
OF THE LEWIS COUNTY SELF-INSURANCE PLAN**

BE IT ENACTED by the Board of Legislators of the County of Lewis, as follows:

Section 1. That Local Law No. 4 - 1956, County of Lewis, as amended by Local Law No. 2 -- 2000, entitled "A LOCAL LAW ENUMERATING RULES AND REGULATIONS OF THE ADMINISTRATION OF LEWIS COUNTY SELF-INSURANCE PLAN" is hereby amended by deleting Section 1, E thereof and substituting the following language therefor so that Section 1, E shall read as follows:

"E. Every new employee and every new participant in the Plan shall, on or before the first day of employment, submit a completed medical questionnaire to be reviewed and accepted for inclusion under the Lewis County Self-Insurance Plan by the Workers' Compensation Committee of Lewis County Board of Legislators or its duly authorized agent, before undertaking any of the duties of his or her employment. Upon a review of the completed medical questionnaire, the Worker's Compensation Committee and/or its duly authorized agent may, at its discretion, request that the individual submit to a physical examination and/or functional capacity test to determine the ability to perform prospective duties and assignments. Failure to submit said medical questionnaire, and/or failure to submit to such physical examination and/or functional capacity test and be so approved and accepted by said Workers' Compensation Committee, or its duly authorized agent, shall result in the denial of all coverage and benefits under the Plan.

The said medical questionnaire as well as all medical examination reports shall be made upon such forms as may be determined from time to time by the Worker's Compensation Committee. The cost of any medical examination as may be requested hereunder shall be at the expense of the Plan."

Section 2. That except as expressly amended or modified herein, Local Law No. 4 -1956, County of Lewis, as amended by Local Law No. 2 -- 2000, entitled "A LOCAL LAW ENUMERATING RULES AND REGULATIONS OF THE ADMINISTRATION OF LEWIS COUNTY SELF-INSURANCE PLAN" shall in all respects remain in full force and effect.

Section 3. That this Local Law shall take effect immediately upon filing with the Secretary of State.




