BE IT ENACTED by the Board of Legislators of the County of Lewis, as follows:

SECTION 1. That the salaries of the following officials of the County of Lewis be and the same are hereby established and are set forth as follows:

County Clerk	\$ 48,420
County Sheriff	\$ 61,468
County Treasurer	\$ 53,609
Highway Superintendent (90%)	\$ 56,400
County Attorney	\$100,000
Public Defender	\$ 65,000
Real Property Tax Director	\$ 45,981
Commissioner of Social Services	\$ 60,232

SECTION 2. That all salaries herein affected, upon the adoption and consummation of this Local Law, shall be effective as of January 1, 2007.

SECTION 3. That the above officials are to receive the above salaries until said salaries are duly amended by the Board of Legislators.

SECTION 4. That the within Local Law shall take effect 45 days after the adoption hereof and all legal requirements having been met.
