**Local Law No. 4 of the Year 2008**

**A LOCAL LAW PROVIDING FOR AN INCREASE IN SALARIES OF CERTAIN LOCAL OFFICIALS AND AMENDING LOCAL LAW NO. 3 – 2007”.**

**BE IT ENACTED** by the Board of Legislators of the County of Lewis, as follows:

SECTION 1. LEGISLATIVE FINDINGS AND PURPOSE.

A. The Board of Legislators finds that Local Law No. 3 – 2007 provided that certain local officials, including the Commissioners of Elections would receive an increase in salary annually consistent with the annual increases provided to employees in collective bargaining agreement.

B. The Board of Legislators further finds that the workload for the Board of Elections Commissioners has increased significantly due to recent changes in elections process and therefore wishes to make an exception to the anticipated raises that would otherwise be available pursuant to Local Law No. 3 – 2007.

C. The Board of Legislators further finds that it demonstrated its intent to recognize the additional workload undertaken by the Board of Elections and to amend the compensation plan for the Board of Elections effective August 14, 2008 whereby it adopted a resolution authorizing an increase in work hours for the Commissioners.

D. The Board of Legislators now wishes to confirm and ratify its previous intent by adopting this local law.

SECTION 2. AMENDMENT TO THE COMPENSATION PLAN.

A. The Compensation Plan of the County of Lewis for the Commissioners of Elections is hereby amended, effective August 14, 2008, and the annual salaries for such Commissioners is established at \$35,526.

B. Section “2,” Paragraph “B” of Local Law No. 3, entitled “A LOCAL LAW PROVIDING FOR PERIODIC INCREASES TO SALARIES FOR CERTAIN LOCAL OFFICIALS,” is hereby amended by inserting the following

sentence: "Except that as to the Commissioners of Elections, the percentage increases referred to herein above, shall not apply for calendar year 2009.

**SECTION 3.** That the within Local Law shall take effect 45 days after the adoption hereof and all legal requirements having been met.




