**A LOCAL LAW REQUIRING INMATES OF THE LEWIS COUNTY PUBLIC
SAFETY BUILDING TO PAY FOR MEDICAL AND DENTAL SERVICES
WHENEVER THIRD PARTY COVERAGE OR INDEMNIFICATION
CARRIED BY SUCH INMATE IS AVAILABLE**

SECTION 1. TITLE:

This local law shall be entitled "A LOCAL LAW REQUIRING INMATES OF THE LEWIS COUNTY PUBLIC SAFETY BUILDING TO PAY FOR MEDICAL AND DENTAL SERVICES WHENEVER THIRD PARTY COVERAGE OR INDEMNIFICATION CARRIED BY SUCH INMATE IS AVAILABLE".

SECTION 2. PURPOSE:

The purpose of this Local Law is to enable the Lewis County Sheriff's Department to seek and obtain reimbursement for the cost of diagnoses, tests, studies or analyses for the diagnosis of a disease or disability, and care and treatment by a hospital, as defined in article twenty-eight of the public health law, or by a physician, or by a dentist that is rendered to inmates of the Lewis County Public Safety Building.

SECTION 3. AUTHORITY:

This Local Law is enacted pursuant to the authority granted by Municipal Home Rule Law § 10 and Corrections Law § 500-h.

SECTION 4. REIMBURSEMENT FOR HEALTH CARE:

The County of Lewis shall be entitled to reimbursement from any third party health insurance coverage or indemnification carried by any inmate of the Lewis County Public Safety Building facility, for the costs of any medical, prescription, and dental services provided to such inmate by the Sheriff, including diagnoses, tests, studies, or analyses for the diagnosis of a disease or disability, and care and treatment by a hospital as defined in Article 28 of the New York State Public Health Law, or by a physician or by a dentist, whenever such service(s) are rendered to such inmate.

SECTION 5. EFFECTIVE DATE:

The law shall take effect immediately.


