#### Local Law No. 1 of the Year 2020

#### A LOCAL LAW PROVIDING FOR INCREASES TO SALARIES FOR CERTAIN LOCAL OFFICIALS

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

##### SECTION 1.

Commencing January 1, 2020, the Compensation Plan of the County of Lewis shall be amended to provide the following salaries for the following County employees appointed to a fixed term of office who are in the middle of their terms:

Commissioner, Department of Social Services	\$ 79,591.00
Director of Real Property Tax Service	\$ 56,899.00
Superintendent of Highways	\$ 74,285.00
Commissioners (2), Board of Elections	\$ 45,835.00

##### SECTION 2.

This Local Law is subject to a permissive referendum and shall take effect 45 days after the adoption hereof and all legal requirements having been met.
